I am writing to voice my opposition to HB-3063

I am an acupuncturist here in Oregon. My masters in of science in Acupuncture and Chinese Medicine was a 4 yr program, that includes ; 705 hrs in Chinese Medicine Theory, diagnosis, and treatment techniques, 660 hours of clinical training, 450 hours in bio-medicine, 90 hours of counseling, communication, ethics, and practice management. I am also a mom of two.

This appears to have good intentions for the healthcare of the public, yet it has lost sight of the bigger picture and the real education and understanding of the chemical make up of each vaccine and the human body.

This bill will discriminate against a minority population (only 2.6% of Oregon population doesn't vaccinate). This mandate is going against our constitutional rights as Americans to vaccinate and care for our children as we (individual parents) seem fit for our family, lifestyle, incomes, genetic healthcare safety and in threat of denied education.

Bottom line ; Vaccines are NOT safe. The general public and children are the sickest they have ever been .
