Dear Legislator,

I am writing to you expressing my serious concerns about HB3063 as a parent and an emergency department RN, Providence Willamette Falls ED, with a background as a biochemistry major, including evaluating research and statistical analysis. To be clear, vaccines are important and powerful tools for public health. However, the more powerfully effective a tool is, the more the damage that can be caused by its misuse. The basis for ethical medical care is informed consent, based on non-biased (think financial) scientific research. This country has dangerously deviated from that fundamental principal (Dr. Marcia Angell, former editor in chief of the New England Journal of Medicine) and is now attempting to completely leave it. HB3063 is an element of a broad nationwide assault on human rights, 29 states currently, that has been funded and orchestrated by vaccine manufacturers to force potential injury or death on this nation's children in the pursuit of enormous profits (Glaxosmithkline's fourth quarter reported pre-tax profit of 1.79 billion dollars) without any legal liability. Vaccine manufacturers were fully relieved of legal liability for injury or death caused by their products in 1986 (federal law passed establishing the National Vaccine Injury Compensation Program which has cost taxpayers more than four billion dollars so far). Consequently, there is a dearth of research demonstrating the safety of multiple doses of vaccines to children's immature and rapidly developing bodies. To those in the fields of science or medicine supporting concerns about vaccine safety invites professional slander. Not only are the vaccine industry pundits data-shopping to create their arguments, they have suppressed research from creating adverse data. That begs the question: what are they concerned will be demonstrated by unbiased research? To those who are inclined to pay attention, immediate concerns are easily recognizable. One brief case in point is injected aluminum. In 2001, the FDA issued a guideline stating that neonatal infants with impaired kidney function (a period of decreased breast or

bottle feeding can quickly equal impaired kidney function) should not receive more than 4-5 micrograms of aluminum per kilogram. That means a newborn that has problems eating after receiving the standard hepatitis B vaccine with more than 200 micrograms of aluminum now has a neurotoxic dose of aluminum impairing her development. That is one vaccine, of reasonably questionable effectiveness and necessity, damage could be obscured for months to years. As we are sadly aware of, large campaign contributions are strongly associated with voting for legislation that increases vaccine sales. What you are likely not aware of is the severe increase in the number of vaccines that have been recommended by the CDC over the last fifty years (1963 – five vaccine doses, 1983 – 24 vaccine doses, 2019 – 72 vaccine doses). Reportedly, there are about 260 more vaccines in development at this time. The United States has the most heavily vaccinated and the most sick children in the developed world. Maybe letting corporate profits bias science and manipulate legislation is a bad idea.
