We've passed major climate legislation to reduce greenhouse gases and clean up fuel and electricity. However, scientists are clear, we are not doing enough.

I am proud to have you as my elected officials because we're taking climate change seriously with this bill. I have been following the journey of this bill for years and I can say for a fact that your work has been outstanding. I have watch you hearing after hearing meet with skilled scientists, policy specialists, with local, national and foreign politicians who put similar legislation in place telling you this is the way to go.
