Dear Members of the Joint Committee on Carbon Reduction,

I am writing to voice strong support for HB 2020, also known as the Clean Energy Jobs bill. My name is Stephen Aiguier and I live in Portland, where I am the President of Green Hammer, a design-build firm and certified B-Corp creating responsible, healthy and inspiring buildings where people live, work and play.

As an Oregon resident and business owner who employs 34 people, I want to stress the economic opportunity presented by HB 2020. The Cap-and-Invest program created by HB 2020 will send the right market signals to drive investment and job growth across the state. A recent economic analysis commissioned by the Governor's office found that passage of the bill would lead to around 50,000 new jobs in Oregon, a 2.5% growth in Oregon's real GDP, and an increase in Oregonians' household income across all tax brackets, with the most going to low-income households. Additionally our firm's primary focus on delivering Zero energy buildings produces projects that are strong candidates for investment opportunities through a program like this, which will accelerate the construction of buildings at the leading edge of technology.

My company, like many others in Oregon, is committed to reducing carbon emissions in the built environment. We measure the success of our company using triple—bottom-line metrics (environmental performance, employee relationships, diversity, involvement in the local community, and the impact our product and services have on those we serve). My firm has garnered national and global recognition for our ability to reduce environmental impact while experiencing healthy profit margins and tripling of revenue and staff over the past 5 years.
