

Dear Health Care Committee,

I attended the HB 3063 hearing today, and wanted to add some thoughts I feel weren't highlighted well from the testimony I did hear.

First off, I heard a few stories of the parents with immune-compromised kids who have cancer. They said they were all vaccinated. They also said the CDC stated vaccines were safe and effective...

But the Supreme Court ruled they were unavoidably unsafe, and article 13.1 in every vaccine insert says they have not been tested for their mutagenic or carcinogenic effects. So which is it??

Also would like to reference an FDA link where they mention vaccines are contaminated with retroviruses and that the cell lines they use in vaccines are tumorigenic – meaning they have been shown to cause tumors when injected into rodents. They admit in same link there's not really any testing done on the effects from these tumorigenic cell lines and retroviruses contained within, which by their very definition ARE mutagenic!

So vaccines are NOT proven to be safe, just safe \*enough\* if they don't continue testing for its carcinogenic and mutagenic affects... But these parents of vaccinated kids who have cancer are saying everyone needs to vaccinate their kid for their kids to feel safe at school!

First, let's connect the dots that vaccines are created with cell lines that have been shown to be carcinogenic in rodents, but we haven't tested to see if they are carcinogenic in humans... And that these little kids with cancer were vaccinated.

Second, they are saying their kid wants to feel safe at school, and supposedly 100% vaccination rates will create that safety??

Well, it can't. The flu vaccine doesn't even necessarily prevent the flu, it supposedly just lessen the severity, plus the vaccine only works for some flu strains. So the flu virus could still be brought to school with 100% vaccination rates, and those same immune-compromised kids will STILL be fearful of getting some illness. They should also be fearful of getting an illness from the grocery store. These immune-compromised kids aren't safe anywhere, and I BET they would not be immuno-compromised had they never had a single vaccine in their life!!

But many in support of keep referencing these immune-compromised kids who really aren't safe anywhere and should be the ones kept in a bubble, not the unvaccinated or partially vaccinated.

Medical exemptions are extremely hard to get in Oregon. I know several families personally who HAVE vaccinated, and their kids have been damaged by the vaccines. Still, they were unable to get a medical exemption. So, no, we can't just get easily medical exemptions, that is why so many ex-vaxxers are against this bill – many of their kids have been vaccine-injure and STILL they didn't qualify for a medical exemption.

Lastly, this is unconstitutional to make into law a One Size Fits All medical procedure to receive an education.

If a bunch of people were dying or severely injured by these diseases, then alright, let's have some serious discussions. But that's NOT happening!

The measles cases barely even left Vancouver... With only a handful of cases in Oregon, and no fatalities to even speak of, there really ISN'T a problem. Only FEAR! All those in favor of were sharing stories of fear of things that haven't happened and didn't happen.
