First of all, this is clearly not an emergency that justifies rushing controversial legislation through without a thorough process of public vetting. On the contrary, there should be public hearings around the State, and broad publicity inviting public comment. This sham move exemplifies the deep dishonesty and corruption surrounding this issue.

Secondly, the mandatory vaccine arguments are ridiculous on their face. If vaccines work, then there would be no danger to a vaccinated person by being in contact with an unvaccinated person, in which case, there's no need to mandate vaccines because it's up to each person to decide what kind of risks they want to take with their own body. On the other hand, If there is a danger to a vaccinated person by being in contact with an unvaccinated person, then that is proof that vaccines don't work, in which case it is absurd to mandate a procedure that doesn't work.

What's more, it is criminal to mandate a dangerous product (Thimerosal (mercury), Aluminum, Formaldehyde) which has killed and damaged so many people that the vaccine companies had to get the tax payers to take on the financial liability for all the harm they were causing in order to stay in business.¹ That in itself tells you that this is not only a fraud, but a criminal fraud. I will continue to push for anyone who is complicit with this criminal fraud to be charged with conspiracy and put in jail.

Measles is a mild childhood disease. When I was a child and a kid got the measles, the parents would do their best to make sure that all of their siblings, and, in some cases, even their friends, got it too, because the symptoms were mild and getting it as a child would immunize you for life. In other words, "measles outbreaks" were encouraged. So to use this mild childhood disease as an excuse to force children to be injected with 115 toxic vaccines by age 6 is criminal.

The vaccine companies claim they are "phasing out" Thimerosal from childhood vaccines. Obviously a vague claim, even if it were made by companies that were honest. However, if a child receives all the CDC-recommended from 6 months to 18 years of age, the amount of Thimerosal has actually increased.²

"Reanalysis of CDC Data on Autism Incidence and Time of First MMR Vaccination" by Brian S. Hooker, Ph.D., P.E. "This study is a re-analysis of Centers for Disease Control and Prevention (CDC) data pertaining to the relationship of autism incidence and the age at which children got their first measles-mumps-rubella (MMR) vaccine. Statistically significant relationships were observed when African-American males were considered separately while looking at those individuals who were vaccinated prior to and after a 36-month age cutoff.

CDC officials observed very similar relationships as early as November 2001, but failed to report them in their final publication. In addition, a relationship is seen when specifically considering children who received a diagnosis of autism without mental retardation. Although this was reported in the original 2004 paper, it was not discussed, nor was any follow-up study

conducted. Preliminary results also suggest the possibility of a synergism between thimerosal exposure and MMR timing leading to a greater risk of autism.”³

Doctor William Thompson, senior scientist at the Centers for Disease Control, said: “We manipulated the data on this study. We omitted data and we threw data out to hide the fact that we saw a causal link between the MMR vaccine and autism.”⁴

“Simpsonwood” was the transcripts of a secret meeting that was held between CDC and 75 representatives of the vaccine industry in which they reviewed a report that CDC had ordered—the Verstraeten study—of a hundred thousand children in the United States vaccine safety database. “There is no denying that there is a connection between autism and thimerosal in the vaccines.” The Verstraeten study showed there’s a clear link, not just with autism but with the whole range of neurological disorders—speech delay, language delay, all kinds of learning disorders, ADD, hyperactivity disorder—and the injection of these vaccines. So GlaxoSmithKline hired a “scientist” to redesigned the study to water down the data by including additional children who are too young to have been diagnosed as autistic. Then they told the public that they’ve lost all the original data. This is what CDC says to this day: That it does not know what happened to the original data in the Verstraeten study. Then they published this other study that is corrupt and crooked. Then Kathleen Stratton from CDC and IOM says “What we need is we need some studies that will disprove the link.” So they work with the vaccine industry to gin up these four phony European studies that are done by vaccine industry employees, funded by the vaccine industry and published in the American Academy of Pediatrics magazine, which receives 80% of its revenue from the vaccine industry. And none of these “scientists” disclose any of their myriad conflicts which conventional ethics rules require them to do.
