Dear Co-chairs Dembrow and Power, and members of the Joint Committee on Carbon Reduction,

My name is Morgan Bechtold-Enge, and I have lived in Oregon my entire life. I'm originally from Southern Oregon, but recently moved to the Portland area. That being said, having lived here and several parts of Oregon, I can say that without a doubt just how precious our state is, and why it is so important that we work together to protect it. This is why I urge you to support HB 2020.

Having lived in the Rogue Valley for the majority of my life, I can say that in just 28 years, I personally have experienced first hand the effects of climate change. The Rogue Valley is known for its beautiful rolling hills and mountain sides. It's truly a spectacular place. However, when you can't see anything except for 25 feet in front of you because the smoke from wildfires is so bad, can you still call a place beautiful at that point?
