Thank your for placing these comments into the official record of commments regarding this Bill. I appreciate the extended comment period.

During the public hearing of SB 2020, it was not clearly defined what issue we were commenting on. I assume we are talking about man caused global warming. and not climate change in general.

I was impressed with the fear and hysteria expressed. Much of this seemed to come from an article in the New York Times, and the New Yorker stating that there was only 11 more years to combat global warming before we all go extinct. The New York Times and New Yorker are not known for reliable sources of quality information. I felt very sorry for some of the female stutdents from Bend HS, who cried feeling they would neverse adulthood. Mr. Gore said in the 1990's, there were only 10 more years until we all would be extinct. We obviously are still here.
