Chair Dembrow and members of the Senate Committee on Environment and Natural Resources,

Please oppose SB 451. With this bill, Covanta seeks renewable energy certificates for electricity generated from the combustion of municipal wastes. Incineration is the most expensive way to handle waste.<sup>[1]</sup> As the Conservation Law Foundation<sup>[2]</sup> points out, this waste is toxic and when incinerated emits toxins such as VOCs, heavy metals, dioxins, sulfur dioxide, carbon monoxide, mercury, carbon dioxide, and furans into the air.

The Oregonian has put a spotlight on the corrupting influence of corporate contributions in their Polluted by Money<sup>[3]</sup> series. Covanta has contributed heavily this legislative cycle to get this bill passed, rewarding Democrats over Republicans in a 4:1 ratio.
