### Oregon Foster Care What is Foster Care?

"Foster Care" means substitute care for children placed by the Department of Human Services or a tribal child welfare agency away from their parents and for whom the department or agency has placement and care responsibility, including placements in foster family homes, foster homes of relatives, group homes, emergency shelters, residential facilities, child care institutions and pre-adoptive homes." ORS 339.133

### **Oregon Foster Care** 2017 Child Welfare Data Book



- **13.7%** of children entering foster care had four or more removal reasons
- **10.8%** of foster care exits occurred within three months of entry
- 56.5% children who left foster care were reunified with parents
- **34.7%** of children were placed with relatives in foster care
- 82.9% were placed with one or more siblings
- 62.3% had two or fewer placements in foster care



### **Oregon Foster Care** National Education Data for Children/Youth in Foster Care

#### **Nationally: By the Numbers**

- 56%-75% of foster students change schools when entering foster care
- **34%** of 17-18-year-olds in foster care have experienced 5+ school changes
- 50% of foster students complete high school by age 18
- 2 9 % of former foster youth attain a bachelor's degree



Did You Know?

Foster Care Youth are 2.5-3.5 times more likely to receive special education services and have higher rates of suspension/expulsion

# **Oregon Foster Care**

**Every Student Succeeds Act Provisions for Children in Foster Care** 

#### **ESSA** provisions are designed to reduce disruptions in education:



- Applies to Child Welfare & Tribal Foster care only;
- Allows foster students to remain in the same school/school district when entering foster care and when their foster home placements change;
- Requires schools to immediately enroll children in foster care after a school move;
- Requires points of contact in every state education agency and many school districts;
- Requires plans for school transportation;
- Requires tracking achievement.



### **Oregon Foster Care** School District Foster Care Data

#### School districts with the highest foster care enrollment (K-12):



- Portland 224
- Salem: 178
- Medford 124
- Eugene 112
- Springfield 97
- Beaverton 90

#### **Additional Support**

Students in Child Welfare custody qualify for an additional weight (.25) for school districts in the State School Fund distribution formula.



## Oregon Foster Care School of Origin

#### What is School of Origin?

If a child's foster home placement moves, the school district/school of origin remains the same. School of Origin applies to foster students between 4 - 21 years old. In addition:

- The school district/school of origin only changes when there is a "Best Interest Finding" made by the juvenile court;
- Individual Education Plan (IEP) teams still have the authority to make all special education placement decisions;
- School district of origin arranges transportation to new school and is reimbursed by DHS.





### **Oregon Foster Care** School Records Transfer

For students who are in substitute care programs (OAR 581-021-0255):

- Schools shall request the student's education records within 5 days of student seeking initial enrollment; and
- When the school receives the request for records, they shall be transferred no later than 5 days after receipt of request.





### **Oregon Foster Care** 2016-17 Graduation Rates

Student Outcome	Foster Care	Non-Foster Care
Graduates	35%	77%
Other Completers	11%	3%
Continuing Enrollment	18%	6%
Non-completers/dropouts	37%	13%

### Oregon Foster Care Foster Care Data in Oregon

#### **Use & Access of Data Across State Agencies**

- DHS and ODE have a data sharing agreement for foster care data;
- Oregon does not currently have verifiable education outcome data for children in foster care;
- Matching data has been complicated by state agencies not having a common denominator for students;
- Foster Care data will be on 2018-2019 State Report Card;
- DHS/HECC share data for higher education outcomes.
- DHS/ODE share data for automatic certification for Free & Reduced Lunch.
