Honorable Members of House Committee on Health Care and Legislators in the House and Senate,

I implore you to OPPOSE HB 3063! There are considerable amendments that would HAVE to be included in order to protect against those most vulnerable to vaccine injury or serious religious and socioeconomic discrimination. There are more than 35,500 students this would immediately impact here in Oregon!

<u>Please consider these important amendments for those who are currently in favor of HB</u> <u>3063:</u>

- Pre-screening for mitochondrial disorders and genetic susceptibilities, including but not limited to MTHFR

- Vouchers for private school. Thousands of Oregon families would fall onto undue hardship without this, and they are all tax-paying citezens who deserve to be treated equally and fairly.

- Access to online education. For those that would opt to homeschool, online education access is critical!

- Allow for religious exemptions

- Broadening of medical exemptions to include family medical history and other important precautions and contraindications outlined by the manufacturers in the actual vaccine inserts (even the CDC I believe added more precautions and contraindications re: family autoimmunity recently to the MMR; previous vaccine injury in said student OR family member MUST be included).
