I write on behalf of KEEN, Inc. to express our support for House Bill 2829, establishing the Oregon Conservation and Recreation Fund. KEEN is based in Portland and employs over 300 people in the state of Oregon. As a values-based brand born for life outside we are committed to advocating for the conservation and stewardship of the places where we live, work and play, especially in our own backyard.

Oregon is steeped from desert to ocean with unique landscapes and sustainable outdoor recreation opportunities around every corner. According to the Outdoor Industry Association, outdoor recreation contributes \$16.4 billion to Oregon's economy and supports 172,000 jobs.

The growing outdoor recreation industry in Oregon creates new economic opportunities and lasting jobs, especially in rural communities. Oregonians and visitors alike are getting out into Oregon's wild places every day to hike, bike, fish, bird watch, paddle, and take in the wonders of Oregon.
