

Good afternoon,

Tomorrow afternoon when you cast your vote on HB 3063, I would like you to seriously consider voting against it. My name is Shantel Schroeder and I am a mother of 3 wonderful girls. Although I understand the reasoning behind the idea of this bill, I do not understand why our medical rights are at risk of being infringed upon. This will take away our RIGHT to CHOOSE medical care/treatment. Allowing this mandatory (other than medical exemptions), medical treatment, is opening doors for the government to force other treatment without choice.

Consider this - Measles was considered a routine childhood inconvenience a generation ago. There have been no deaths, very few hospitalizations, and paltry number of cases obviously indicates that federal and state action is not necessary. Why not have a hearing instead on the out-of-control growth of Autism? Every year we see 50,000 to 100,000 new cases per year, but that health catastrophe does not seem to merit even a comment from state or federal officials.

I personally have a nephew who was a healthy, thriving little boy who was ahead of every milestone, including walking around 9 months and talking small sentences by a year.
