"Commissions increased the amount of leveraged funding from \$12.01 million in 2001 to over \$51 million in 2010."

"In 2009 the Commission in collaboration with the Coos County Local Public Safety Coordinating Council received a five-year \$625,000 Drug Free Communities Grant to fund programs in our local communities. The goal of this grant is to decrease youth substance abuse and to strengthen collaborations within the county."

"Hood River County reported that:

"Caseworkers were handling case loads of up to 150 youth in the Juvenile Department, but caseloads were cut by twothirds, with minor first time offenses being diverted to teen court where youth are given the opportunity to make amends for their mistakes and clear their records."
