NEDCO and Willamette Neighborhood Housing Services are two nonprofit affordable housing development and counseling agencies that merged as of January 1st. Our mission is to serve low and moderate income Oregonians to increase their financial security and build assets. We serve clients across four offices covering six counties: Lane, Linn, Benton, Lincoln, Marion and Clackamas Counties.

NEDCO and Willamette Neighborhood provide financial and pre-purchase education and counseling to low and moderate income first-time homebuyers. Our financial wellness classes help clients understand their financial picture, create a monthly budget and take control of their credit report. Our homebuying classes focus on unpacking the process, connecting with local lenders and real estate agents, planning for those unexpected homeownership expenses and avoiding predatory lending practices. We build upon all of this knowledge in oneon-one counseling sessions that ensure our clients are ready to take the step, that they have an action plan and that their financial and credit picture are ready to help them build assets and gain financial stability.

We are not alone in this work. We are part of the network of 17 homeownership centers that serve all 36 counties throughout Oregon. Homeownership centers are a neutral, third party support for first-time homebuyers in analyzing and repairing their credit, identifying their short and long-term goals, evaluating the mortgage product that is right for them and helping first-time buyers access financial resources for their purchase.
