My name is Virginia Farver and I live in Fort Collins, CO. I'm requesting that you put my information into the exhibits for SB 281 - SB 282 - SB 283. Thank-you for allowing these Bills to hopefully go forward through these committees. I'm working in Colorado with groups trying to pass similar Bills.,

I lost my beautiful young son Rich, on October 11, 2008 from GBM Brain Cancer. Rich was also a student on the SDSU San Diego Campus and involved in a 'Brain Cancer Cluster.' Four men who all worked in Nasatir Hall, Room 131, were diagnosed with brain cancers in 2008. In November of 2009 Ms. Laurel Amtower was diagnosed with GBM brain cancer who also worked in this area of campus. Laurel passed away on August 29, 2010 nine months after diagnosis at the age of 44. Laurel left behind a 12 year old daughter. There have also been other deaths since the original 2009 articles.

There is a cell tower on campus called HPWREN (High Performance Wireless Research & Educational Network) a backbone node to the UCSD Supercomputer Center in San Diego. HPWREN is also mission control for SDG&E. I have attached a picture of the HPWREN cell tower and please notice the dead tree foliage on the surrounding trees. He felt like he would disappoint me because even if he got into law school, he wouldn't make it through. It is time to get our medical doctors educated on these symptoms. Rich also had panic attacks, which is a form of depression. Depression is one of the first symptoms of wireless over exposures. How many kids are being medicated with anti-depressants wrongfully.

Dr. Sam Milham has testified in Arizona with Mr. Paul Harding about smart meters. Dr. Milham has also been working closely with the CDC. The flu used to be a seasonal event and now it is a year round event. It is because of the proliferation of wireless. Another reason to protect our kids!
