Housing Oregon is a membership-based statewide association of affordable housing community development corporations (CDCs) committed to serving and supporting low-income Oregonians across the housing needs spectrum – from homeless to homeowner. We support and strengthen our members by providing training on industry best practices, peer support networks, communications, and advocacy on local and statewide policy issues.

We are working towards a day when every Oregonian has a safe and healthy place to call home.

Housing Oregon urges support for SB 5512 in order to ensure Oregon Housing and Community Services (OHCS) has the necessary resources to address the affordable housing and homelessness crisis affecting our state. We support Governor Kate Brown's leadership proposing \$406.1 million in resources and investments to focus on housing stability for families with children, veterans, and the chronically homeless, as well as accelerating the supply of housing throughout Oregon.

To effectively meet the challenge, however, we urge committee members to support investing \$200 million in new rental and homeownership development through the Local Innovation and

Fast Track (LIFT) Housing Program (POP 107). In addition, we support investing \$100 million to preserve existing affordable housing (POP 110)

Other OHCS rental, homeownership development and homelessness program budget requests we support include:

- \$15 million for Attainable Rental Market Acquisition (POP 111)
- \$15 million for Greater Oregon Housing Accelerator (POP 105)
- \$15 million for Housing Development Guarantee
- \$20.5 million for reducing children's homelessness (POP 108)
- \$50 million for EHA/SHAP (POP 109)
- \$20 million for Rental Market Resources (POP 104)
- \$50 million for Permanent Supportive Housing (POP 103)

Oregon's Statewide Housing Plan, recently released by OHCS, identified over 85,000 new units are needed to house those households earning below 30% of Median Family Income (MFI) in units affordable to them. OHCS' 4-year goal is to triple the existing pipeline of affordable rental housing – up to 25,000 homes in the development pipeline by 2023. We must do more.

In order for OHCS to be able to successfully implement these programs and goals in the Statewide Housing Plan we urge you to support the Department's request for position authority to give them the ability to hire additional staff (POP 101 & 102). OHCS is currently understaffed, causing delays in housing development. Additional staff would help OHCS to more efficiently and effectively deliver current programs.

Oregon is at a turning point. Supporting this historic investment in OHCS to effectively address our state's housing crisis is a critical first step.
