## **BILL DESCRIPTION:**

Proposes amendment to Oregon Constitution specifying that Legislative Assembly, or people through initiative process, may enact laws limiting or prohibiting certain contributions made to candidates for public office.

Refers proposed amendment to people for their approval or rejection at special election held on same date as next primary election.

## **AGENCY WRITTEN ANALYSIS:**

The -5, -6, -7, and -8 amendments still refers the amendment for approval during the next primary election. The fiscal impact to the Secretary of State is indeterminate. Each additional ballot measure in an election requires staff time to answer questions, run a Financial Estimate Committee and Explanatory Statement Committee, and process Voter's Pamphlet submissions.

The size of the Voter's Pamphlet is determined by the number of candidates, measures and referendums that are placed on an election ballot. This proposed measure will add a minimum of two pages to the Voter's Pamphlet, and more pages would need to be added if any arguments are submitted for or against

the measure. Adding pages to the Voter's Pamphlet increases the cost for production and printing. A wide range of factors influence the additional cost for each page added.

If there are a large number of measures or referendums, and/or a large number of arguments for and against, the additional Voter's Pamphlet pages added by this measure could require us to print a twovolume Voter's Pamphlet, which can increase the overall printing and distribution costs of a Voter's Pamphlet by an estimated \$400K to \$500K.
