RE: SB 810

Dear Chair Prozanski and Members of the Committee:

I am writing you to support SB 810. On June 30, 2015, I was riding my motorcycle in Portland, Oregon and was stopped in line on the northbound ramp to I-5 from Alberta Street. I was behind a number of cars waiting to be metered onto the freeway.

Without any warning I was suddenly struck from behind by a car with so much force that it pushed both me and my motorcycle under the car in front of me. The car continued to drive on and struck a barrier wall down the ramp with so much force that it broke the front wheel axle.

I was trapped underneath the running car and suffered burns to my face and body. My mouth was torn open and a tooth was broken. I ended up having a fractured vertebra, fractured hip and pelvis, three broken ribs, a bruised lung, lacerated liver, and multiple cuts and abrasions that required stitches. I had to undergo a long a painful rehabilitation process and still have not fully recovered.

This accident has changed my life forever. The driver of the car denied that he was on his cell phone at the time of the accident and was only issued a traffic citation for careless driving and a fine of \$435. I believe that the driver was more than careless and should have been charged with a crime, or at a minimum, the driver should have been required to take a driver-safety course so that he would not injure other riders in the future.

I love riding motorcycles and understand the risks of riding. What I cannot accept is carelss and reckless drivers hurting riders and passengers and not facing any real consequences. I know that passing this bill will not change what happened to me but I feel strongly that the next driver that carelessly injures a motorcyclist or their passenger should be held accountable. I urge you to support SB 810.
