RE: Responses to questions asked during Ways and Means presentation on March 25, 2019

Dear Ways and Means Public Safety Subcommittee Members,

Thank you for the opportunity to provide information related to the Oregon Department of Corrections (DOC). Below are responses to the questions asked during our presentation to the Ways and Means Public Safety Subcommittee on Monday, March 25, 2019.

1. How can friends and family share photos with adults in custody (AICs) today?

DOC's current contract with Telmate allows posting and exchange of photos between friends and family and AIC. Access to the internet for AICs is secured by a third party who reviews and secures outside applications similar to Photo Patch. Photos can also be mailed in according to the Inmate Mail Rule.

2. Of all injuries within DOC, what are the trends/data?

DOC has seen an overall decreasing trend in injuries over the last three years. Strains, slips, trips, and falls account for 34 percent of all DOC injuries. These, and other categories and percentages, are listed below.

Strains	20 percent
Slips/trips/falls	14 percent
AIC involved	18 percent
Blood exposure	14 percent
Contusions	10 percent
Other	24 percent

3. What is the demographic of hospital watches (i.e. gender, age, race)?

Charts with our top drivers for hospital trips are attached – broken down by age and gender. A breakdown including race would take a significant amount of additional work and chart reviews.

4. Does Oregon Corrections Enterprises (OCE) manufacture license plates?

As mentioned, OCE does not manufacture license plates. However, the concept was explored by OCE at the request of the Oregon Department of Motor Vehicles (DMV) in May 2016. Over a 16-month period, OCE examined current contract pricing and the variety of plates being produced under the current contract. The equipment need for plate production totaled just over \$1,500,000. The result of the cost comparison to the existing contract amount showed no cost savings to DMV or Oregonians at the time. The current vendor contract expires in 2020, at which time new pricing negotiations are expected. OCE is in continued contact with DMV and plans to provide an updated pricing proposal in 2020.
