- Eleven members
  - Nine members appointed by the Governor to three-year terms (ADDAE, DOGO, DUNCAN, FOX, GARY-SMITH, MANNING, OLOL)
  - Two legislators, on appointed by the Senate President (SEN. MONROE) one appointed by Speaker of the House of Representatives (REP. BYNUM) each of whom has a two-year term.
- Appointments shall be made to ensure representation of the Black population in Oregon

#### DUTIES AND AUTHORITY: ORS 185.410 to 185.430

- Elect a chair and vice-chair
- Monitor programs and legislation concerning needs of the Black population
- Identify and research problem areas and issues affecting the Black community and recommend actions to the Governor and Legislature
- Be a community-government liaison for the Black community
- Encourage Black representation on state boards and commissions
- Employ an executive director and other staff necessary to carry out its function; may establish special committees
- Meet annually with other Advocacy Commissions
