- Fifteen members; no more than two full terms; can be removed for "good cause" by the Governor, including for the reason of 3 unexcused absences in a 12-month period:
 - One fire and casualty underwriter (vacant)
 - One representative of industrial plants regularly employing licensed electrician (vacant)
 - One representative of the light and power industry (PALMROSE)
 - One electrical equipment supplier who qualifies by experience in the industry (HALL)
 - One elevator manufacturing representative (MCNEILL)
 - One electrical equipment manufacturing industry representative who qualifies by experience and training in electricity (vacant)
 - Two journeymen electricians (FLEGEL, MILLER)
 - One electrical inspector (SMITH)
 - Two electrical contractors (KYLE, RICHARDS)
 - One municipal building official (JACKSON)
 - One journeyman elevator installer (CARMONY)
 - One owner or manager of a commercial office building (TOTTEN)
 - One public member who does not receive compensation from any business interest represented by other members (PUGH)

DUTIES AND AUTHORITY: ORS 455.138, 455.144

- Advisory to the Director of the Department of Consumer and Business Services (DCBS) in administering the electrical program described in ORS 479.510 to 479.945 and the elevator program described in ORS 460.005 to 460.175.
- Select chair and vice-chair
- Impose civil penalties for violation of ORS 479.510 to 479.945 or rules adopted for the administration or enforcement of ORS 479.510 to 479.945
- Meet at least four times per year at time and place specified by Director of Department of Consumer and Business Services after consultation with board
