STATEMENT OF ECONOMIC INTEREST (ORS 244.050): Not required

STATUTORY QUALIFICATIONS: ORS 675.310

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Five members
 - Two members who are licensed occupational therapists with no less than three years experience in occupational therapy immediately preceding their appointment (HEDRICK PARK, PERKINS)
 - One member who is a licensed occupational therapy assistant (HILL)
 - Two members of the public (JENKINS II, MOORE)
- Members are entitled to compensation and expenses as provided by ORS 292.495
- Members serve a term of four years, but at the pleasure of the Governor

DUTIES AND AUTHORITY: ORS 675.320 to 675.340

- Will organize and elect a chairperson and vice chairperson, who may hold the position for one year or until the election of qualified successor
- May authorize payments for necessary supplies, office equipment, investigations and other expenditures necessary to fulfill duties
- May suspend, revoke, or invalidate licenses for nonpayment of renewal fees
- May restore licenses that have been suspended, revoked, or voided
- Adopt license and license renewal fees (subject to approval by the Oregon Department of Administrative Services) and collect license application and renewal fees
- Investigate alleged violations and generally supervise the practice of occupational therapy in the state
- Rulemaking authority
- Establish minimum requirements for continuing education, limited permit, and necessary supervised field work
- May impose civil penalty for violations and establish schedule of civil penalties
