<u>TERMS:</u> 3-year term: June 1, 2019 to May 31, 2022

APPOINTMENT/CONFIRMATION AUTHORITY: ORS 684.130

STATEMENT OF ECONOMIC INTEREST (ORS 244.050): Not required

### STATUTORY QUALIFICATIONS: ORS 684.130

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Seven members appointed by the Governor to three-year terms including:
  - Five chiropractors who must have practiced chiropractic in this state for five years prior to appointment (KNECHT, KOUZES, ROMANICK, **VERMILLION**, WAGGONER)
  - Two public members who are residents of the state (REED, TAYLOR)
- Upon sufficient proof of inability or misconduct to Governor, member must be dismissed

## <u>DUTIES AND AUTHORITY:</u> ORS 684.140-684.200

- Enforce and exercise supervision over the practice of chiropractic within this state
- Adopt rules for the administration of ORS chapter 684
- Adopt schedule of minimum educational requirements
- Upon receipt of a complaint, investigate, take affidavits, summon witnesses, require evidence production and take testimony
- Establish standards and tests to determine qualifications of chiropractic license applicants
- Issue, deny, suspend and revoke licenses; enjoin persons practicing in violation
- Determine acceptable chiropractic schools, colleges, institutions, and training
- Prescribe time, place, method, manner, scope and subjects of examinations
- Appoint peer review committees to evaluate complaints against chiropractic physicians
- Enter into contracts to make services available to impaired chiropractic physicians and adopt rules for the administration of a diversion program
