Please support the following bills:

## SB931 - Updates FERNS notification system:

- SB931 simply asks for a 24-48 hour notice so neighbors and water users can prepare and protect themselves by doing things like turning off water intakes that could be impacted, or closing bee-boxes to protect pollinators.
- Good Neighbors don't mind telling each other when there will be a helicopter overhead.
- SB931 is a common sense measure that calls for corporations to be better neighbors, and let nearby homes, schools and businesses know when they will be spraying herbicides out of helicopters.
- SB931 asks that companies report **what chemicals they actually sprayed** once their operation is done, neighbors and water users deserve to know this information in an accurate timely manner.
- Modern Technology is already being used by the industry and the Department of Forestry already has the tools in place to provide more transparency today, **this is a reasonable solution to a major problem.**

## SB926 - Stops Aerial Spray on State Lands

- Oregon's Public Forest-lands are important **sources of drinking water** for many communities, homes and schools.
- Public lands are needed for **public enjoyment**, and users should be protected from aerial spraying.
- Federal Public Lands banned this practice decades ago in the interest of public health and safety. State Public Lands should follow their lead and recognize the importance of mixed-use on public forest lands.

• **Hikers, campers and anglers have no way of knowing** which ridge they shouldn't cross or which bend around the river might put them at risk.
