Oregon Medical Marijuana Program (OMMP) patients continue to lose access to growers, therefore loosing access to affordable cannabis. Of the OMMP patient population, 51% live on reduced income. They simply cannot afford cannabis from dispensaries, not even discounted cannabis. One inexpensive way to reduce this burden to OMMP patients would be to allow those OMMP growers using the Oregon Medical Marijuana Online System (OMMOS) to record transfers to any registered OMMP patient, caregiver or grower. Currently OMMP growers cannot make recorded transfers in OMMOS to OMMP participants, other than their designated patient.

On December 1, 2017, I gave testimony at the Oregon Health Authority (OHA) regarding the hardships that SB 1057 and HB 2198 would cause patients. I urged OHA to edit OMMOS to allow growers to transfer cannabis to all OMMP patients. In response to testimonials, the OHA said that change would require legislative action and that "in addition, growers are only able to transfer marijuana to the patient that they are growing for. Growers are unable to give marijuana to anyone other than the patient they grow for." I am required to report monthly to OMMOS and cannot report transfers to other patients.

The Oregon Cannabis Commission (OCC) reports recommendations for the OMMP to legislators. I was optimistic because most of the commission members at every OCC meeting said they wanted to hear from OMMP participants. The OCC put in their agenda. "A patient hearing tour" that then changed to a listening tour. Those listening tours never materialized. I started a survey of OMMP participants, see attached results. The survey results were submitted to the OCC and its subcommittees regularly with updated numbers. We all hoped that the OCC, in particular the OCC Subcommittee on Patient Access would act on our request to recommend to legislators to allow OMMP growers using OMMOS to transfer to OMMP patients. This request was initially written into the final draft of the Patient Access Subcommittee's recommendations. At the last moment, before the draft was finalized, the chairperson of the Patient Access Subcommittee made a motion, which passed, to change the wording to only allow OLCC/CTS OMMP growers to transfer cannabis to any registered OMMP patient. This discriminates against all OMMP growers using OMMOS.

As of last fall, 2,084 OMMP growers reported into one of two reporting systems: 1,219 growers reporting into OMMOS, and 865 growers reporting into CTS. The majority of OMMP growers, 59% use OHA/OMMOS and only 41% OMMP growers use OLCC/CTS to report. Over 600 OMMP participants in the survey support legislative change to allow OMMP growers reporting into OMMOS to transfer cannabis to all registered OMMP participants. Why did the OCC ignore this request? Please make the necessary legislative change to allow registered OMMP growers to transfer to all registered OMMP participants using OMMOS.

From 4/28/18 to 6/14/18, there were 222 OMMP participants that signed a statement to support legislative change that allows any registered OMMP grower using Oregon Medical Marijuana Online System, to record transfers to any registered OMMP participant. These 222 signatures were previously submitted to the Oregon Cannabis Commission, their Patient Access Subcommittee and the Product Integrity and Regulated Market Subcommittee.

With the strong support from these OMMP patients and the community, I started an electronic survey on 6/21/18. From 6/21/18 to 3/7/19 an additional 428 people have filled out the survey (survey questions attached at the end of this report).

Of those that filled out the survey, 409 supported the legislative change. The combined 409 supporters plus the 222 previous signatures brings the total to **631 people** that support this legislative change.
