SB 219: Adds eligible entities for RIF

One modification:

 Adds Oregon's federally recognized Indian tribes as eligible entities for the Regional Infrastructure Fund (RIF)



Regional Solutions Overview: *Purpose*

Community and economic development program operating out of the Governor's Office

- Recognizes the unique needs of each region of the state
- Coordinates state action to elevate access and engagement
- Utilizes place-based capacity to work with local communities to identify priorities, solve problems, and seize opportunities
- Works with local governments, public and private entities, philanthropy, and academic institutions
- Engages with community and economic development efforts to put a regional economy on a trajectory of higher growth by increasing the productivity of firms, communities, and workers raising the standards of living for all

Regions are strategically aligned with the 11 federally designated economic development districts in Oregon



Five key members appointed by the Governor:

- 1. Convener
- 2. Private Sector Representative
- 3. Philanthropic Representative
- 4. A member recommended by AOC
- 5. A member recommended by LOC

Additional members added by these appointees.

Regional Solutions Committees role:

- 1. Establish Regional priorities for community and economic development in the region
- 2. Assist Regional Solutions coordinators and teams with connecting to local resources
- 3. Consider, review, and recommend projects

- 11 Regional Solutions Teams (RS Teams)
- Each RS Team: Includes five core state agencies and a coordinator
- The role of the RS teams is to engage with community and economic development projects

Regional Solutions Overview: *Projects Using the RIF Tool*

- Maupin Broadband
 - Region: North Central
 - RIF Investment: \$410K
 - Matched funds: \$2.5M
- Butte Creek Mill + Ice House
 - Region: Southern Oregon
 - RIF Investment: \$200K
 - Matched funds: \$2.5M
- Big Creek Dam Project
 - Region: South Valley/Mid Coast
 - RIF Investment: \$250K
 - Matched funds: \$2.4M

SB 219A:
