

Chairs Senator Beyer and Representative McKeown Joint Committee on Transportation Salem, Oregon

April 22, 2019

Thank you for the opportunity to comment on HB2284. These comments are provided on behalf of the Midwater Trawlers Cooperative (MTC). MTC is a non-profit trade association that represents 28 large commercial trawl vessels and the majority of our member vessels are home-ported in Newport. MTC members are some of the primary users of Newport's International Terminal, and we have been paying customers at that location for more than 40 years. MTC members fish off the west coast for whiting and groundfish and they are a major part of Oregon's successful Distant Water Fleet- which means our vessels spend a portion of the year fishing in federal fisheries off of Alaska. On this particular issue, MTC has also been the spokesperson for the broader fishing community in Newport. MTC members as well as the broader fishing community are opposed to HB2284. We believe HB2284 is unnecessary and it undermines the current activities at the Port. We also believe it jeopardizes a segment of Oregon's commercial fishing industry which contributes over \$100 million annually into Oregon's economy.

Supporters of the bill appear to argue that the bill is necessary to diversify Newports economy, including potentially increasing freight traffic. As I will note, we believe Newports economy has been growing and diversifying without the bill and, indeed, while not certain to be fruitful, MTC supports increasing freight in Newport. We just dont believe it should be done in a manner that hurts our robust and growing seafood harvesting and processing sector.

I co-chaired the committee to get the bond measure passed in 2006 to rebuild the mixed-use International Terminal. The intent of the bond measure was 3-fold: deal with the environmental concerns of the leaking contaminents into Yaquina Bay and rebuild the work dock to continue to support commercial fishing and to reintroduce shipping which had not occurred in the Port since 1999.

The environmental remediation took up a majority of the \$15.4 million dollar bond measure so the Port turned to state and federal grants and loans to complete the initial phase of the project. They have been actively seeking shipping opportunities since that time, but no deals have worked out. Contrary to what you might have heard, businesses are not beating down the door to ship out of Newport- there are several operational challenges in the Newport location including a small space (3 acres), no railroad,

bridge height constraints and a limit on the number of large trucks that can deliver goods to the Terminal on a daily basis.

As the Port embarked on a process to reintroduce shipping, Oregon's commercial fishing industry continued to grow and prosper. With a rebuilt Terminal, several seafood processors, access to three shipyards on the Yaquina River and a multitude of service providers, Newport is the only full-service Port in Oregon. With Hatfield Marine Science Center, NOAA and the OSU Marine Studies Initiative, Newport is also the go-to Port for all things marine research and education-related. Tourism is huge for the state of Oregon and the tourists come to Newport in part, for the access to an authentic working waterfront. To see the boats up-close and experience life in a fishing town.

Over 300 commercial fishing vessels call Newport home and more vessels are trying to access yearround moorage in Newport. The Newport industry supports thousands of Oregon jobs and in 2017 we were responsible for over 17% of the earned income in Lincoln County, contributing \$171 million into the state's economy. The Port of Newport and the rebuilt Terminal are critical to this success.

The Terminal is critical to the industry's success because it is where the vessels are serviced. Where they load, off-load and store fishing gear, vessels that are too large to fit at the fuel dock have fuel delivered by tankers to the vessels, seafood is unloaded at the Terminal, vessels stage at the Terminal before moving up-river to the shipyards for routine maintenance and large overhaul projects, and because it is the only space in the Port of Newport that large fishing vessels can moor at. There are no other docks in the Port that can accommodate the size and needs of these local vessels. Other businesses that support fishing are adjacent to the Terminal and investment on private land around the Terminal is developing even more services to support fishing. Right now the Terminal is full with a transient squid fleet that followed the squid stock north. There are several vessels, unloading equipment and semi trucks working daily to offload squid and truck it down to California for processing.

HB2284 threatens the economy built around the Port of Newport with no real benefit. Removing the right of local tax-paying citizens to elect their leadership and have a say in how their Port is run is contrary to democracy. HB2284 is unneccesary – fishing does not now, nor has it ever, had an undue influence over the Port Commission. In fact, in the last twenty years non-fishing interests have had the majority on the 5-person Commission in all but two years. In the last 20 years, 78% of candidates running for Port Commission ran unopposed – this leaves plenty of room for others to get involved if they don't like the direction the Port is headed in. HB2284 takes the extraordinary step of assigning who can sit on the Commission. It mandates a fishing minority and promotes a shipping majority. HB2284 is a direct threat to Newport's fishing industry.

All types of commercial fishing boats are using the Terminal throughout the year. Between April 1 and May 15th and between November 1st and January 10th the Terminal is fully utilized with fishing boatsthey are often tied two and three deep because there isn't enough dock space to all fit alongside the pier. There is a significant amount of commerce happening for the community, the county and the State. On an annual basis the vessels that use the Terminal are contributing \$500K directly to the Port and they are spending millions locally and in the state of Oregon to support their businesses. The vessels that use the TermainI just agreed to support a proposal to raise the rates charged by almost 70% in the next fiscal year.

The Newport fishing industry is not opposed to shipping. We do support an operation that can work with existing users in the space available. HB2284 is unenessary and it has the potential to harm the fishing industry which will have negative economic impacts throughout the county and state of Oregon. That is why the Lincoln County Board of Commissioners, the City of Newport, the Port of Newport and the Port of Toledo all support local control. The Port of Newport's Commercial Fishing User's Committee that represents all commercial users in the Port opposes this legislation. Over the weekend we collected over 150 signatures on a petition opposing HB2284. These are local citizens, commercial fishermen, recreational fishermen, mayors, and businesses who are all opposed to HB2284. MTC and the broader fishing community urge this Committee to take no further action on this divisive and unhelpful legislation.
