Honorable Committee Members:

My name is Lesley Roehr and I'm from Wilsonville, Oregon. As a retired peace officer and former crime victim, I oppose HB 2932.

There are currently 913 foreign felons in Oregon prisons. 132 for homicides, 458 seix offenders. Illegally entering the country itself is a crime under 8 USC 1325. This bill would reward foreign criminal defendants in the State of Oregon by shielding them from the consequences of their original illegal act, including potential deportation to their home countries.

HB 2932 sets a dangerous precedent by allowing politicians - not judges - to determine what factors the court may consider during criminal proceedings. What other potential crimes and relevant information could the legislature decide that the courts must ignore? And of course, a defendant's status as a foreign national and potential flight risk is essential information for a judge to have when setting bail. Once a criminal flees the country, it is nearly impossible to get them back to face justice.

In addition, this bill would grant extra time for foreign defendants to consider their plea not afforded to citizens accused of the same crime. That is unequal application of the law and is clearly unconstitutional!

This bill prioritizes foreign criminals above law-abiding immigrants and citizens. Every year that the legislature grants criminal offenders more rights and victims less rights, you send the message that our lives don't matter. That our families don't matter.

America is the greatest, most generous country on earth, and people understandably want to come here. But they've got to do it legally. Rewarding foreign criminals incentivizes unlawful behavior and is a huge slap in the face not only to crime victims, but to millions of legal immigrants.

Please, pass laws to PROTECT VICTIMS NOT CRIMINALS and vote NO on HB 2932. Thank you for your consideration.
