[SB 2A]: "Allows listed eastern Oregon counties that undertake economic opportunity analysis to designate up to 50 acres outside urban growth boundaries for industrial and other employment uses notwithstanding statewide planning goals related to agriculture, forest use or urbanization. Excludes high-value farmland. Requires county coordination with State Forester and nearby cities."..." SECTION 3. ORS 197.714 is amended to read: 197.714. (1) Notwithstanding the authority granted in ORS 197.713 and section 2 of this 2019 Act to allow industrial or other employment use development, [including accessory uses subordinate to the industrial development, in areas zoned for industrial use,] when a county or its designee considers action under ORS 197.713 [(1)] or section 2 of this 2019 Act for land within 10 miles of the urban growth boundary of a city, the county or its designee shall give notice to the city at least 21 days prior to taking action."
