[HB 5005]: I DO NOT SUPPORT Article XI-Q Bond indebtedness relating to:

[(k) Department of Transportation, Dundee Bypass Right of Way for \$32,435,000]

Yamhill County does not need this expenditure and the State of Oregon does not need this indebtedness for the Department of Transportation, Dundee Bypass Right of Way.

Yamhill County needs funding for the repair and structural upgrading of the rural roads which support; what is left of the agricultural economy of this area and to support safe use and passage by people who live here.

Yamhill County (colloquially referred to as "Scam-Hill County") is festooned with special interest appointments on the Yamhill County Parkway Committee which is the driving force behind the [\$32,435,000] bond request.

[HB 5005]: I DO NOT SUPPORT Revenue Bond indebtedness relating to: [Direct Revenue Bonds: Housing and Community Services Department for \$500,000,000]. [Pass-Through Revenue Bonds: Housing and Community Services Department for \$600,000,000].

Incurring Bond indebtedness to support the "Homeless Industrial Complex" is foolhardy and ill advised.

Yamhill County has more "Non-profit and Not-for profit corporations" sucking on the public's teats than a herd of sows with their corresponding piglets.
