# Need-Based Aid: The Oregon Opportunity Grant (OOG)

Oregon's only state-funded, need-sensitive grant program to help low-income Oregonians, including young people and adults, achieve their academic goals.

- Used at eligible public and private Oregon colleges and universities.
- Starting with the 2018-19 academic year, maximum award amounts based on approximately 13% cost of attendance.

**GOAL:** To increase college enrollment, completion, and affordability for Oregon students who have demonstrated financial need.



# Oregon Opportunity Grant: Eligible Students

<u>U.S. citizens</u> or permanent noncitizen residents\*

<u>Oregon residents</u> and out-of-state members of federally recognized tribes with historical ties to Oregon

Those who attend <u>eligible 2- or 4-year public/private</u> nonprofit postsecondary institutions located & headquartered in Oregon

<u>Undergraduates</u> with no prior baccalaureate degrees, enrolled at least half time

Those who demonstrate financial need

Foster youth –awards prioritized, regardless of FAFSA filing date, start of enrollment, or EFC

Up to equivalent of 12 terms or 8 semesters at full-time enrollment, prorated for half-time enrollment.



<sup>\*</sup> Also students eligible for in-state tuition under Tuition Equity guidelines

# Increased Maximum OOG Award Amount in 2018-19

Oregon Opportunity Grant MAXIMUM AWARDS INCREASED in 2018-19

Set awards based on percentage of Cost of Attendance (COA)

- Percentages for 2018-19 at 13% COA (prior year), rounded up to nearest \$100
  - Increased to \$2,600 at community colleges
  - Increased to \$3,200 at eligible 4year colleges and universities
  - Prior fixed award amount in 2017-18 was set at \$2,250

#### **POLICY LOGIC**

Goal: Increase Student Support and Affordability

- Aligning annual maximum awards with cost of attendance will help students who are most sensitive to annual increases in tuition, fees and other costs
- Higher, more meaningful OOG award amounts support student access, retention and completion
- Equalizes purchasing power for students in 2-year and 4-year Public Institutions



#### Projected Awards & Disbursements at Current Service Level (CSL)

#### March Co-Chairs' Budget

- •HECC will disburse up to \$72.5 million in OOG funds to students for the 2019-20 academic year, i.e., 48% of Current CSL
- •If additional funds become available, HECC will either make additional awards for 2019-20, spend the remaining balance in the second year of the biennium, or some combination.
- Permits HECC to serve a similar number of students in each academic year

Increases EFC limit and applied-through date, award until funds exhausted (Pell EFC limits: 5,486 for 19-20; est. 5,586 for 20-21), maximum awards at 13% prior-year cost of attendance.

# The Oregon Promise

Oregon Promise grant program helps cover community college tuition costs for recent high school graduates and GED® test graduates.

- Established by Senate Bill 81 (2015)
- Grants apply after federal and state grant aid.
- Students may be eligible for up to 90 attempted college credits approximately two years at full-time enrollment.
- Grant sizes ranged from minimum of \$1,000 to maximum of \$3,687 in 2018-19 (based on average CC tuition)

**GOAL:** To increase college enrollment, completion, and affordability for recent high school graduates and GED® test graduates.



# Opening the Door: The Oregon Promise

## **Student Eligibility**



Recent Oregon high school graduate or GED® test graduate

credit limit, completed or attempted, including accelerated learning

2.5+ GPA

at HS graduation or 145 on all GED® tests



Enroll for 6+ credits at an Oregon community college within 6 months of graduation



Oregon resident for at least 12 months prior to college attendance

# **Apply**

File a FAFSA/ORSAA
File an Oregon Promise
Application

Expected family contribution (EFC) may also be used as needed to control program costs

#### To maintain eligibility, students must:

- Remain continuously enrolled for at least 6 credits each term
- File a complete FAFSA/ORSAA application by published deadline
- Have earned fewer than 90 college credits

# 2019-2021 Oregon Promise Grant (OPG)

#### Projected Awards & Disbursements under Current Service Level

#### March Co-Chairs' Budget

- •2019-21 CSL budget for the Oregon Promise is \$41.5 M.
- •The GRB funds the program at \$21.5 M, eliminating the program for the second year of the biennium.
- Co-chairs' budget funds the program at \$30 M.
- •Limited funding requires the implementation of cost control measure (setting an EFC cap).
- •HECC/OSAC initiates Fall 2019 awarding with an EFC cap, and implements communication plan.

#### **Awarding Impact**

- HECC to disburse up to \$15 million in OPG funds for the 2019-20 academic year, i.e., 50% of Co-chairs budget of \$30M.
- 2019-20 Awards as of 5/6/19\*
- Cost control EFC cap at 18,000.
- 7,041 awards to students with EFCs at or below 18,000
- 2,000+ students with higher EFCs in "pending" award status
- HECC/OSAC will make additional awards if funding increases



<sup>\*</sup> The application deadline for most students is early June, so there will likely be more applicants and awardees

#### Decrease GPA to 2.0 & No EFC Limits

- GPA decrease would only impact 2020-21 awards (new students)
- Approximately 15% of HS Grads have a GPA between 2.0 and 2.49
- No EFC limits
- 4% tuition increase per year
- Same EFC demographics
- Same trends re: enrollment level, pickup rates, and renewal rates

# Interface between: Oregon Opportunity Grant and Oregon Promise

- Progon Opportunity Grant (OOG) serves as a first dollar reducing directly the costs of the Oregon Promise for thousands of participating students
- > 50 % of Oregon Promise authorized awards, during Fall 2018, went to low income-high need students who qualified for the Oregon Opportunity Grant
- > 44 % of Oregon Promise award recipients, during Fall 2018, received the minimum ORP award amount, OOG and Pell covered tuition expenses
- Investments in the Oregon Opportunity grant that increase the EFC award limit directly reduce awarding costs for Oregon Promise

Differentiating maximum awards at 15% of prior-year cost of attendance (COA) for students at EFC 0, and at 13% prior-year COA for everyone else.


# **Emergency Assistance: Background**





unforeseen economic hardships as they pursue a higher education credential, sometimes resulting in dropouts.







# **Emergency Assistance: National Practices**

#### Minnesota

- \$175,000 per year
- 5 institutions in 2017 (award per institution unknown)
- 5 institutions in 2018 (award per institution unknown)

#### Texas

- Proposal in legislature
- \$2,000,000 per year
- # of institutions unknown, but up to \$50K per institution



# Emergency Assistance: Efforts at Oregon Institutions

40 institutions surveyed

Grants, scholarships, loans, food pantry access, bus passes, direct payments for goods or services, etc.

Average annual budget approx. \$25,000

Average award per student approximately \$675



## Emergency Assistance: Pilot Concept

HECC will gather/convene partners to share proven methods

HECC will coordinate with state agencies to support local/institutional partnerships

Establish a statewide emergency grant (institutions to decide how to use it)

Establish an advisory committee to create a minimum definition of qualifying emergency, determine a minimum institutional match/maintenance of effort requirement for funds eligibility, and review funds utilization and outcomes.

HECC to proportionately distribute grant funds to OOG eligible institutions.
