This message is being sent to inform you that the Oregon Legislature is poised to adopt a Bill that will subject religious institutions to unduly burdensome or discriminatory land use regulations as compared to nonreligious institutions.

RLUIPA (Religious Land Use Institutionalized Persons Act) requires governments to treat houses of worship as favorably as nonreligious assemblies. HB 3844 will amend Oregon Law to regulate nonreligious institutions less stringently than certain religious institutions.

The Senate Committee on Environment and Natural Resources has been informed about this problem but is poised to move ahead regardless.
