Subject:	HB 2057 – Relating to State Department of Agriculture maximum license fee

House Bill 2057 increases the statutory maximum limits of the license fees for commercial weights and measuring devices by 15% and limits the annual rate of fee increases allowable per year to 3% beginning July 1, 2020 until June 30, 2026. The current statutory caps were established in 2007 and will be reached with the ratification of fees included in HB 5003, the Department of Agriculture's fee bill. The Department's budget bill (HB 5002) assumes passage of HB 2057 and the subsequent 3% increase that would be effective July 1, 2020. The fee increase is anticipated to generate \$102,649 Other Funds in the 2019-21 biennium and \$205,298 Other Funds in 2021-23.
