"(5) It is not an unfair labor practice or a violation of subsection (2)(a) of this section for a labor organization to charge the following employees reasonable fees and costs for representation that are unrelated to the negotiation of a collective bargaining agreement, provided that the employees are not members of the labor organization and have not voluntarily entered into a fair-share agreement:

25 "(a) A police officer of a city or municipal police department;

26 **"(b) A sheriff or deputy sheriff; or** 

"(c) A police officer commissioned by a university under ORS
352.121 or 353.125.
