- Eight members (must be residents of Oregon), appointed to four year terms by the Governor
 - o Five certified or licensed appraisers (BAIRD, BROOKS, DILL, MONTEAUX, UPHOLD)
 - o One appraiser management representative (**RICHARDS**)
 - o One individual from a financial institution or who is a mortgage banker
 - One public member who is not engaged in professional real estate activity, is not state certified or licensed and does not have a direct financial interest in a person certified or licensed, not employed by financial institutions or mortgage bankers
- Maximum of two terms
- Serve at the pleasure of the Governor

DUTIES AND AUTHORITY: ORS 674.200 to 674.340

- Operate as semi-independent state agency
- Regulate the activities of state-licensed appraisers and state certified appraisers
- Certify, license and supervise state certified and state licensed appraisers
- Select chair and vice chair
- Ensure all real estate appraisals conform to the law
- Issue subpoenas and compel witnesses for proceedings before the board
- Adopt rules, establish educational requirements, professional code of responsibility and rules to register out-ofstate appraisers
- Set and collect annual registry fees; adopt budgets
- Sue and be sued in its own name
