- Seven members appointed by the Governor to three-year terms:
 - o Four members holding CPA permits and actively engaged in public accountancy (FRONK, SULLIVAN, WRIGHT, YOUNG-OLIVER)
 - One member holding CPA permit for five years and employed in private industry, education or government or actively engaged in public accountancy practice (**ROBINSON**)
 - o One public member (FRANCO RICHARDSON)
 - o One public accountant licensed for five years and actively engaged in public accountancy (MORRIS)
- No more than three consecutive three-year terms until a period at least equal to the appointed terms has elapsed

<u>DUTIES AND AUTHORITY:</u> ORS 673.010 - 673.475

- Regulate the practice of public accounting
- Grant certificates to CPAs; license public accountants
- Adopt professional code of conduct for CPAs and public accountants
- Rulemaking
- Take disciplinary action against licensees
- Institute injunction proceedings to halt violations; appoint hearings officer
- Appoint Peer Review Committee; approve applications for operation of alternative peer review programs
- Allow holder of a license in another state (verified as being substantially equivalent in requirements or skills)
 to practice public accountancy in Oregon if the holder maintains a valid certificate and license in good
 standing as a certified public accountant
