- Nine members appointed by the Governor to three-year terms commencing July 1:
  - Six residents of Oregon with doctoral or master's degrees with primary emphasis in psychology and properly licensed (BJORKQUIST, GROVER, JOHANNSEN, JONES, NISHI-STRATTNER, ZIEGLER)
  - Three public members who are Oregon residents (**HAGEN**, SCHERMER, WEINER)
- All members must be residents of the state, be geographically and ethnically diverse
- A board member shall be removed immediately if the member is not a resident of the state, has been absent from three consecutive board meetings, without at least one excused absence, and not licensed and good standing at time of retirement
- Members required to subscribe to oath of office
- One consecutive reappointment only
- Members serve at the pleasure of the Governor

DUTIES AND AUTHORITY: ORS 675.110, 675.130, 675.150

- Regulate practice of psychology through qualification of applicants, granting or denial of renewals, and disciplinary proceedings, including the ability to issue civil penalties
- Formulate code of conduct
- Establish standards for training and continuing education
- Collect license fees
- Maintain register of all living psychologists licensed under ORS 675.010 to 675.150
- May institute injunction proceedings to enjoin unlawful practice of psychology in Oregon
- Elect chairperson
