- Five members (ANDERSON, CONDE, O'HAGAN, PALMER, WILLIAMSON)
- Citizens, residents, and electors of Oregon
- Removable by Governor for cause, after public hearing
- May not have financial interest in racing animals or tracks and may not make certain wagers

DUTIES AND AUTHORITY: ORS 462.250, 462.270, 462.272, 462.275, & 462.300

- Elect Chair and Vice-Chair; appoint Executive Director and other employees as necessary
- License, regulate, supervise and inspect all race meets and locations.
- Prepare and promulgate rules to govern race meets
- Issue subpoenas, administer oaths, take depositions
- Cooperate with racing commissions of other jurisdictions for the betterment of racing
- Cause an annual audit to be made of the financial records of all beneficiaries of the Oregon Racing Commission Account
