    other fiduciary services for persons with inadequate resources: ALLEN, FRIEDMAN, KAO, LEYKAM,
    SCHREIBER, WILLIAMS
- Must be citizens of the state, broadly representative of persons residing in facilities, racial and ethnic minorities, add who have knowledge and interest in problems of elderly
- Must be representative of all areas of the state
- Representative of all demographics who are served by Long Term Care Ombudsman
- Members are eligible for reappointment

### <u>DUTIES AND AUTHORITY:</u> ORS 441.417 – 441.418

- Select chairperson and vice chairperson
- Monitor the Long Term Care Ombudsman Program
- Advise Governor and Legislature on program
- Nominate three persons for ombudsman
