

House Bill 2159

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Revenue)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Imposes tax on distribution of inhalant product based on percentage of wholesale sales price. Defines inhalant product as including inhalant-form nicotine but excluding cigarettes, tobacco products and cannabinoids.

Requires licensing of place of business of inhalant product distributor. Establishes licensing program within Department of Revenue. Provides that licensing provisions become operative on January 1, 2020.

Establishes civil and criminal penalties.

Applies to inhalant product sold on or after January 1, 2020.

Takes effect on 91st day following adjournment sine die.

2 Relating to inhalants; creating new provisions; amending ORS 131.602; prescribing an effective date;

4 **Be It Enacted by the People of the State of Oregon:**

SECTION 1. As used in sections 1 to 25 of this 2019 Act:

5
6 (1) **"Business" means any trade, occupation, activity or enterprise engaged in for the**
7 **purpose of selling or distributing inhalant product in this state.**

8 (2) **"Consumer" means any person who purchases inhalant product in this state for the**
9 **person's use or consumption or for any purpose other than reselling the inhalant product to**
10 **another person.**

11 (3) **"Contraband inhalant product" means inhalant product or packages containing**
12 **inhalant product that do not comply with the requirements of sections 1 to 25 of this 2019**
13 **Act.**

14 (4) **"Distribute" means:**

15 (a) **Bringing, or causing to be brought, into this state from outside this state inhalant**
16 **product for sale, storage, use or consumption;**

17 (b) **Making, manufacturing, mixing, formulating or fabricating inhalant product in this**
18 **state for sale, storage, use or consumption in this state;**

19 (c) **Shipping or transporting inhalant product to retail dealers in this state, to be sold,**
20 **stored, used or consumed by those retail dealers;**

21 (d) **Storing untaxed inhalant product in this state that is intended for sale, use or con-**
22 **sumption in this state;**

23 (e) **Selling untaxed inhalant product in this state; or**

24 (f) **As a consumer, being in possession of untaxed inhalant product in this state.**

25 (5) **"Inhalant delivery system" has the meaning given that term in ORS 431A.175.**

26 (6)(a) **"Inhalant-form nicotine" means nicotine that:**

27 (A) **Is in a form that allows the nicotine to be delivered into a person's respiratory sys-**

1 **tem;**

2 **(B) Is inhaled for the purpose of delivering the nicotine into a person’s respiratory sys-**
3 **tem; and**

4 **(C)(i) Is not approved by, or emitted by a device approved by, the United States Food and**
5 **Drug Administration for a therapeutic purpose; or**

6 **(ii) If approved by, or emitted by a device approved by, the United States Food and Drug**
7 **Administration for a therapeutic purpose, is not marketed and sold solely for that purpose.**

8 **(b) “Inhalant-form nicotine” does not include cigarettes as defined in ORS 323.010 or to-**
9 **bacco products as defined in ORS 323.500.**

10 **(7) “Inhalant product” means:**

11 **(a) A substance, other than cannabinoids, in any form sold for the purpose of being**
12 **vaporized or aerosolized by an inhalant delivery system; or**

13 **(b) Inhalant-form nicotine.**

14 **(8) “Inhalant product distributor” means:**

15 **(a) Any person engaged in the business of selling or otherwise dispensing inhalant prod-**
16 **uct in this state who brings, or causes to be brought, into this state from outside this state**
17 **inhalant product for sale;**

18 **(b) Any person who makes, manufactures, mixes, formulates or fabricates inhalant**
19 **product in this state for sale in this state;**

20 **(c) Any person engaged in the business of selling inhalant product outside this state who**
21 **ships or transports inhalant product to retail dealers in this state, to be sold by those retail**
22 **dealers;**

23 **(d) Any person, including a retail dealer, who sells untaxed inhalant product in this state;**
24 **or**

25 **(e) A consumer in possession of untaxed inhalant product in this state.**

26 **(9) “Inhalant product manufacturer” means any person who makes, manufactures,**
27 **mixes, formulates or fabricates inhalant product for sale.**

28 **(10) “Inhalant product wholesaler” means any person who engages in the sale of inhalant**
29 **product to any retail dealer for purposes other than use or consumption.**

30 **(11)(a) “Retail dealer” means any person who is engaged in the business of selling or**
31 **otherwise dispensing inhalant product to consumers.**

32 **(b) “Retail dealer” includes the operators of, or recipients of revenue from, all places**
33 **where inhalant product is made or stored for ultimate sale to consumers.**

34 **(12) “Sale” means any transfer, exchange or barter, in any manner or by any means, for**
35 **consideration or a gift by a person engaged in the business of selling inhalant product.**

36 **(13) “Untaxed inhalant product” means inhalant product for which the tax required under**
37 **sections 1 to 11 of this 2019 Act has not been paid.**

38 **(14) “Wholesale sales price” means the price paid for untaxed inhalant product to or on**
39 **behalf of a seller by a purchaser of the untaxed inhalant product. For inhalant product**
40 **manufacturers, “wholesale sales price” includes all amounts paid for any component or in-**
41 **gredient of the inhalant product.**

42 **SECTION 2. (1) A tax is hereby imposed upon the distribution of inhalant product in this**
43 **state. The tax imposed by this section is intended to be a direct tax on the consumer, for**
44 **which payment upon distribution is required to achieve convenience and facility in the col-**
45 **lection and administration of the tax. The tax shall be imposed on an inhalant product dis-**

1 **tributor at the time of distribution.**

2 **(2) The tax imposed under this section shall be imposed, subject to the provisions of**
 3 **subsection (3) of this section, at the rate of:**

4 **(a) 95 percent of the wholesale sales price of inhalant product other than that described**
 5 **in paragraph (b) or (c) of this subsection.**

6 **(b) 95 percent of the wholesale sales price of disposable cartridges containing inhalant**
 7 **product.**

8 **(c) 95 percent of the wholesale sales price of a disposable inhalant delivery system that**
 9 **is sold containing inhalant product.**

10 **(3)(a) In a transaction between parties that are not related or affiliated and that are**
 11 **presumed to have roughly equal bargaining power, the wholesale sales price is the price paid**
 12 **by the purchaser for the untaxed inhalant product.**

13 **(b) In a transaction between parties that are related or affiliated or presumed not to have**
 14 **equal bargaining power, the wholesale sales price is determined on the basis of comparable**
 15 **arm's-length wholesale transactions as described in paragraph (a) of this subsection.**

16 **(4) A tax under this section is not imposed on an inhalant delivery system that, when**
 17 **sold, does not contain inhalant product.**

18 **(5) If the tax imposed under this section does not equal an amount calculable to a whole**
 19 **cent, the tax shall be equal to the next higher whole cent.**

20 **SECTION 3. (1) Except as otherwise provided in sections 1 to 11 of this 2019 Act, the tax**
 21 **imposed by sections 1 to 11 of this 2019 Act shall be paid by each inhalant product distributor**
 22 **to the Department of Revenue on or before the last day of January, April, July and October**
 23 **of each year for the preceding calendar quarter.**

24 **(2) With each quarterly payment, the taxpayer shall submit a return to the department,**
 25 **in such form and containing such information as the department shall prescribe.**

26 **(3) The tax, penalties and interest imposed by sections 1 to 11 of this 2019 Act shall be**
 27 **a personal debt, from the time liability is incurred, owed by the taxpayer to the State of**
 28 **Oregon until paid.**

29 **(4) The returns required of inhalant product distributors under this section shall be filed**
 30 **by the inhalant product distributors regardless of whether any tax is owed by the inhalant**
 31 **product distributors.**

32 **(5)(a) The department for good cause may extend the time for making any return under**
 33 **sections 1 to 11 of this 2019 Act. The extension may be granted at any time if a written re-**
 34 **quest is filed with the department within or prior to the period for which the extension may**
 35 **be granted. The department may not grant an extension of more than one month.**

36 **(b) When the time for filing a return is extended at the request of a taxpayer, interest**
 37 **shall be added at the rate established under ORS 305.220, from the time the return was ori-**
 38 **ginally required to be filed to the time of payment.**

39 **SECTION 4. (1) An inhalant product wholesaler or an inhalant product distributor, or**
 40 **another person dealing in or storing inhalant product, shall keep receipts, invoices and other**
 41 **pertinent records related to sales of inhalant product in the form required by the Depart-**
 42 **ment of Revenue. Each record shall be preserved for five years from the time to which the**
 43 **record relates, or for as long as the inhalant product wholesaler, inhalant product distributor**
 44 **or other person retains the inhalant product to which the record relates, whichever is later.**
 45 **During the retention period and at any time prior to the destruction of records, the depart-**

1 ment may give written notice to the inhalant product wholesaler, inhalant product distribu-
 2 tor or other person not to destroy records described in the notice without written permission
 3 of the department. Notwithstanding any other provision of law, the department shall pre-
 4 serve reports and returns filed with the department for at least five years.

5 (2) The department or its authorized representative, upon oral or written demand, may
 6 make examinations of the books, papers, records and equipment of persons making sales of
 7 inhalant product and any other investigations the department deems necessary to carry out
 8 the provisions of sections 1 to 25 of this 2019 Act.

9 **SECTION 5.** (1) The Department of Revenue has authority, by order or subpoena to be
 10 served with the same force and effect and in the same manner as a subpoena is served in a
 11 civil action in the Oregon Tax Court or a circuit court to require the production at any time
 12 and place the department designates of any books, papers, accounts or other information
 13 necessary to carry out sections 1 to 11 of this 2019 Act. The department may require the
 14 attendance of any person having knowledge in the matter, and may take testimony and re-
 15 quire proof material for the information, with power to administer oaths to the person.

16 (2) If a person fails to comply with a subpoena or order of the department or to produce
 17 or permit the examination or inspection of any books, papers, records and equipment perti-
 18 nent to an investigation or inquiry under sections 1 to 11 of this 2019 Act, or to testify to
 19 any matter regarding which the person is lawfully interrogated, the department may apply
 20 to the Oregon Tax Court, or to the circuit court of the county in which the person resides
 21 or where the person is, for an order to the person to attend and testify or otherwise comply
 22 with the demand or request of the department. The department shall apply to the court by
 23 ex parte motion, upon which the court shall make an order requiring the person against
 24 whom the motion is directed to comply with the request or demand of the department within
 25 10 days after the service of the order, or within the additional time granted by the court, or
 26 to justify the failure within that time. The order shall be served upon the person to whom
 27 it is directed in the manner required by this state for service of process, which service is
 28 required to confer jurisdiction upon the court. Failure to obey any order issued by the court
 29 under this section is contempt of court. The remedy provided by this section is in addition
 30 to other remedies, civil or criminal, existing under the tax laws or other laws of this state.

31 **SECTION 6.** Except as otherwise provided in sections 1 to 11 of this 2019 Act, a person
 32 aggrieved by an act or determination of the Department of Revenue or its authorized agent
 33 under sections 1 to 11 of this 2019 Act may appeal, within 90 days after the act or determi-
 34 nation, to the Oregon Tax Court in the manner provided in ORS 305.404 to 305.560. These
 35 appeal rights are the exclusive remedy available to determine the person's liability for the
 36 tax imposed under sections 1 to 11 of this 2019 Act.

37 **SECTION 7.** The Department of Revenue shall administer and enforce sections 1 to 25
 38 of this 2019 Act. The department is authorized to establish rules and procedures for the im-
 39 plementation and enforcement of sections 1 to 25 of this 2019 Act that are consistent with
 40 sections 1 to 25 of this 2019 Act.

41 **SECTION 8.** Except as provided in sections 1 to 11 of this 2019 Act or where the context
 42 requires otherwise, the provisions of ORS chapters 305 and 314 as to the audit and exam-
 43 ination of returns, periods of limitation, determination of and notices of deficiencies, as-
 44 sessments, collections, liens, delinquencies, claims for refund and refunds, conferences,
 45 appeals to the Oregon Tax Court, stays of collection pending appeal, confidentiality of re-

1 turns and the penalties relative thereto, and the procedures relating thereto, apply to the
 2 determinations of taxes, penalties and interest under sections 1 to 11 of this 2019 Act.

3 **SECTION 9.** If the Department of Revenue believes that the collection of any tax imposed
 4 under sections 1 to 11 of this 2019 Act or any amount of the tax required to be paid to the
 5 state or of any determination will be jeopardized by delay, the department shall make a de-
 6 termination of the tax or amount of tax required to be collected, noting that fact upon the
 7 determination. The amount determined is immediately due and payable, and the department
 8 shall assess the taxes, notify the person and proceed to collect the tax in the same manner
 9 and using the same procedures as for the collection of income taxes under ORS 314.440.

10 **SECTION 10.** (1) All moneys received by the Department of Revenue under sections 1 to
 11 25 of this 2019 Act shall be deposited in the State Treasury and credited to a suspense ac-
 12 count established under ORS 293.445. The department may pay expenses for the adminis-
 13 tration and enforcement of sections 1 to 25 of this 2019 Act out of moneys received from the
 14 tax imposed under section 2 of this 2019 Act. Amounts necessary to pay administrative and
 15 enforcement expenses are continuously appropriated to the department from the suspense
 16 account.

17 (2) After the payment of administrative and enforcement expenses and refunds or credits
 18 arising from erroneous overpayments, the department shall credit the balance of the moneys
 19 received by the department under this section to the General Fund.

20 **SECTION 11.** Any consumer subject to the tax resulting from a distribution of inhalant
 21 product and from whom the tax has not been paid shall, on or before the 20th day of the
 22 month following receipt of the inhalant product, file with the Department of Revenue a re-
 23 port of the amount of inhalant product received by the consumer in the preceding calendar
 24 month in the detail and form as the department may prescribe, submitting with the report
 25 the amount of tax due.

26 **SECTION 12.** Notwithstanding the confidentiality provisions of section 8 of this 2019 Act,
 27 the Department of Revenue may disclose information received under sections 1 to 25 of this
 28 2019 Act to the Oregon Health Authority to carry out the provisions of ORS 431A.175,
 29 431A.183 and 433.835 to 433.875.

30 **SECTION 13.** (1) Any person engaging or seeking to engage in the sale of inhalant prod-
 31 uct as an inhalant product distributor shall file an application for an inhalant product
 32 distributor's license with the Department of Revenue. The application shall be on a form
 33 prescribed by the department. An inhalant product distributor shall apply for and obtain a
 34 license for each place of business at which the inhalant product distributor engages in the
 35 business of distributing inhalant product. A fee may not be charged for the license. For the
 36 purposes of this section, a vending machine in and of itself is not a place of business.

37 (2) A person may not engage in the business of distributing inhalant product in this state
 38 without a license.

39 (3) A person filing an application under this section shall include with the application a
 40 written statement certifying that the person will comply with the provisions of ORS 180.483
 41 and 180.486 where applicable.

42 **SECTION 14.** (1) The Department of Revenue may require any person subject to sections
 43 1 to 25 of this 2019 Act to place with the department an amount of security that the de-
 44 partment determines is necessary to ensure compliance with sections 1 to 25 of this 2019 Act.

45 (2) The amount of the security shall be fixed by the department but, except as provided

1 in subsection (3) of this section, may not be greater than twice the estimated tax liability
 2 of a person for the reporting period under sections 1 to 25 of this 2019 Act, determined in a
 3 manner the department considers proper.

4 (3) In the case of a person who, pursuant to section 16 of this 2019 Act, has appealed the
 5 decision of the department to cancel, suspend or revoke a license, the amount of the security
 6 may not be greater than twice the tax liability of the person for the reporting period under
 7 sections 1 to 25 of this 2019 Act, determined in a manner the department considers proper,
 8 or \$10,000, whichever is greater.

9 (4) The limitations provided in this section apply regardless of the type of security placed
 10 with the department. The required amount of the security may be increased or decreased
 11 by the department subject to the limitations provided in this section.

12 **SECTION 15.** (1) Upon receipt of a completed application, the statement required by
 13 section 13 of this 2019 Act and any security required by the Department of Revenue under
 14 section 14 of this 2019 Act, the department shall issue an inhalant product distributor's li-
 15 cense to an applicant. A separate license shall be issued for each place of business of the
 16 inhalant product distributor within this state. Each license issued by the department shall
 17 include an identification number for the license. A license is valid only for engaging in
 18 business as an inhalant product distributor at the place designated on the license, and the
 19 license shall at all times be conspicuously displayed at the place for which the license is is-
 20 sued. The license is not transferable and is valid until canceled, suspended or revoked.

21 (2) The department may not issue a license to an applicant if the department determines
 22 or has reason to believe that the applicant will not comply with the provisions of ORS
 23 chapter 323 or sections 1 to 25 of this 2019 Act or any other state or federal tax law relating
 24 to cigarettes, tobacco products or inhalant product.

25 (3) Notwithstanding ORS 305.280, an applicant may appeal, in the manner provided in ORS
 26 305.404 to 305.560, to the magistrate division of the tax court the department's decision not
 27 to issue a license to the applicant within 30 days of the date of the department's decision.

28 (4) For purposes of this section, an application for renewal of an inhalant product
 29 distributor's license shall be considered the same as an application for an initial inhalant
 30 product distributor's license.

31 **SECTION 16.** (1) The Department of Revenue may cancel, suspend or revoke a license
 32 issued to an inhalant product distributor if the inhalant product distributor fails to:

- 33 (a) Pay any tax or penalty due under sections 1 to 25 of this 2019 Act;
- 34 (b) Otherwise comply with any provision of ORS chapter 323 or sections 1 to 25 of this
 35 2019 Act or any rule adopted under ORS chapter 323 or sections 1 to 25 of this 2019 Act; or
- 36 (c) Comply with any other state or federal tax law relating to cigarettes, tobacco pro-
 37 ducts or inhalant product.

38 (2) Notwithstanding ORS 305.280, an inhalant product distributor may appeal, in the
 39 manner provided in ORS 305.404 to 305.560, to the magistrate division of the tax court the
 40 department's decision to cancel, suspend or revoke a license within 30 days of the date of the
 41 department's decision under subsection (1) of this section.

42 **SECTION 17.** Notwithstanding section 8 of this 2019 Act, information on the license of
 43 an inhalant product distributor is not confidential. The Department of Revenue may publicly
 44 disclose or publish a list of names of inhalant product distributors, along with any other in-
 45 formation set forth on a license.

1 **SECTION 18.** (1) A sales invoice for the wholesale sale of inhalant product in this state
 2 must contain the following:

3 (a) The name and address of the seller, the name and address of the purchaser, the date
 4 of the sale of the inhalant product, the quantity and product description of the inhalant
 5 product, the price paid for the inhalant product and any discount applied in determining the
 6 price paid for the inhalant product;

7 (b) The applicable license identification number for the inhalant product distributor;

8 (c) A certified statement by the inhalant product distributor that all taxes due under
 9 sections 1 to 11 of this 2019 Act have been or will be paid; and

10 (d) Any other information the Department of Revenue may prescribe by rule.

11 (2) An inhalant product distributor must provide a copy of the sales invoice to the pur-
 12 chaser of the inhalant product and the purchaser shall retain a copy of the invoice for five
 13 years following the date of purchase.

14 (3) Each purchaser that then sells the inhalant product to a subsequent purchaser shall
 15 provide the subsequent purchaser with a sales invoice that meets the requirements of this
 16 section.

17 (4)(a) A purchaser in possession of inhalant product that is unable to present a sales in-
 18 voice that meets the requirements of this section is presumed to be in possession of inhalant
 19 product for which the tax imposed under sections 1 to 11 of this 2019 Act has not been paid.

20 (b) In the case of a purchaser in possession of untaxed inhalant product, the tax is due
 21 immediately, along with a penalty equal to 100 percent of the tax due. Amounts due under
 22 this paragraph may be collected as provided in section 9 of this 2019 Act.

23 (c) If the purchaser in possession of untaxed inhalant product is a retail dealer, the de-
 24 partment may impose a civil penalty for the possession of untaxed inhalant product. A civil
 25 penalty imposed under this paragraph may not exceed \$1,000 per violation. A civil penalty
 26 imposed under this paragraph may be appealed to the magistrate division of the tax court in
 27 the time and manner prescribed in ORS 305.404 to 305.560.

28 (5) This section does not apply to a consumer in possession of inhalant product with a
 29 wholesale sales price of less than \$50.

30 **SECTION 19.** (1)(a) A civil penalty may be imposed by the Department of Revenue on any
 31 person who violates any provision of sections 1 to 25 of this 2019 Act.

32 (b) A civil penalty imposed under this subsection may not exceed \$1,000 per violation.

33 (c) A civil penalty imposed under this subsection may be appealed to the magistrate di-
 34 vision of the tax court in the time and manner prescribed in ORS 305.404 to 305.560.

35 (2) Any person who, in violation of section 22 (4) of this 2019 Act, prevents entry or ex-
 36 amination by the department shall be fined a maximum of \$500 per day for the first seven
 37 days and \$1,000 per each additional day thereafter until the department is allowed access.

38 (3) Any person required to obtain a license as an inhalant product distributor under
 39 sections 1 to 25 of this 2019 Act who knowingly engages in business as an inhalant product
 40 distributor without a license or after a license has been canceled, suspended or revoked is
 41 guilty of a Class C felony.

42 (4) Any person required to make, render, sign or verify any report under sections 1 to
 43 25 of this 2019 Act who makes any false report with the intent to defraud is guilty of a Class
 44 C felony.

45 (5) Any person who knowingly violates any provision of sections 1 to 25 of this 2019 Act,

1 except as otherwise provided in this section, is guilty of a Class A misdemeanor.

2 (6) Any person who, with intent to defraud, makes, alters, forges or utters a false receipt
3 or invoice recording a sale of inhalant product in this state is guilty of a Class C felony.

4 (7) In addition to any other sentence the court may impose upon a conviction under this
5 section, the court may order the forfeiture of the instrumentalities used in violating sections
6 1 to 25 of this 2019 Act and the proceeds resulting from a violation of sections 1 to 25 of this
7 2019 Act.

8 **SECTION 20.** (1) A person commits the crime of unlawful distribution of inhalant product
9 if the person knowingly sells or distributes, possesses or transports for sale or distribution
10 or imports for sale or distribution inhalant product that does not comply with sections 1 to
11 25 of this 2019 Act.

12 (2) The offense of unlawful distribution of inhalant product is classified as follows:

13 (a) If the amount of inhalant product tax avoided in committing the offense over a 90-day
14 period totals less than \$1,000, the offense is a Class A misdemeanor.

15 (b) If the amount of inhalant product tax avoided in committing the offense over a 90-day
16 period totals \$1,000 or more, but less than \$5,000, the offense is a Class C felony classified
17 as crime category 3 of the sentencing guidelines grid of the Oregon Criminal Justice Com-
18 mission.

19 (c) If the amount of inhalant product tax avoided in committing the offense over a 90-day
20 period totals \$5,000 or more, but less than \$10,000, the offense is a Class C felony classified
21 as crime category 5 of the sentencing guidelines grid of the Oregon Criminal Justice Com-
22 mission.

23 (d) If the amount of inhalant product tax avoided in committing the offense over a 90-day
24 period totals \$10,000 or more, the offense is a Class B felony classified as crime category 7
25 of the sentencing guidelines grid of the Oregon Criminal Justice Commission.

26 (3) Inhalant product sold, distributed, possessed, transported or imported in violation of
27 subsection (1) of this section is contraband inhalant product and subject to seizure and
28 forfeiture. If seized and forfeited under this subsection, the contraband inhalant product
29 shall be destroyed.

30 (4) In addition to any other sentence the court may impose upon a conviction under this
31 section, the court may order the forfeiture of the instrumentalities used in violating this
32 section and the proceeds resulting from a violation of this section.

33 (5) As used in this section, "inhalant product tax" means the amount of tax due under
34 sections 1 to 11 of this 2019 Act, if the tax was timely paid upon first distribution of the
35 inhalant product in this state.

36 **SECTION 21.** The penalties provided in sections 18 and 19 of this 2019 Act are additional
37 to all other penalties provided under sections 1 to 25 of this 2019 Act.

38 **SECTION 22.** (1) As used in this section, "premises" means a place of business:

39 (a) That is licensed under sections 1 to 25 of this 2019 Act; or

40 (b) That the Department of Revenue has reasonable cause to believe is used for the sale
41 or distribution of inhalant product.

42 (2) The department may enter and examine the premises of any person or business at
43 any time an individual is present. If the department seeks entry under this section outside
44 of regular business hours, this section requires that department personnel have reasonable
45 cause to believe that an individual is present in the premises. The department may enter and

1 **examine:**

2 (a) All areas used in or by the business operated at the premises, regardless of whether
3 patrons are permitted to be present in those areas; and

4 (b) Areas not located at the premises that reasonably appear to be used by the person
5 or business to store items listed in subsection (3) of this section.

6 (3) The department may examine:

7 (a) Business records related to the sale or distribution of inhalant product;

11 (4) A person may not interfere with or hinder an entry or examination by the department
12 under this section.

13 (5) This section does not authorize the department to enter or examine an area used for
14 residential purposes, unless the area is located on a lot or parcel not zoned for residential
15 use or where residential use is not allowed as a nonconforming use.

16 **SECTION 23.** (1) Any contraband inhalant product found by an authorized representative
17 of the Department of Revenue or any law enforcement agency may be immediately seized
18 and is subject to forfeiture. If seized and forfeited under this subsection, the contraband
19 inhalant product shall be destroyed.

20 (2) Notwithstanding ORS 305.280, a seizure and forfeiture made under this section may
21 be appealed to the magistrate division of the tax court within 30 days of the date of the sei-
22 zure in the manner prescribed in ORS 305.404 to 305.560.

23 **SECTION 24.** (1) To promote administrative and regulatory efficiency and compliance
24 with laws regulating or taxing inhalant product, the Department of Revenue may transmit
25 information obtained under sections 1 to 25 of this 2019 Act to the proper officers of gov-
26 ernmental units inside and outside Oregon that:

27 (a) Regulate or tax inhalant product or enforce laws relating to inhalant product; and

28 (b) Reciprocate in the exchange of relevant information.

29 (2) Governmental units that receive information pursuant to this section may use or
30 disclose the information solely for the purpose of administering or enforcing laws regulating
31 or taxing inhalant product.

32 **SECTION 25.** (1) The Director of the Department of Revenue is authorized to enter into
33 an inhalant product tax refund agreement with the governing body of any Indian reservation
34 in this state. The agreement may provide for a mutually agreed upon amount as a refund
35 to the governing body of any inhalant product tax collected under sections 1 to 11 of this 2019
36 Act in connection with the sale of inhalant product to Indians on the Indian reservation, or
37 the use, storage or consumption of inhalant product by Indians on the Indian reservation.
38 This provision is in addition to other laws allowing tax refunds.

39 (2) There is continuously appropriated to the director, from the suspense account estab-
40 lished under ORS 293.445 and section 10 of this 2019 Act, the amounts necessary to make the
41 refunds authorized by subsection (1) of this section.
