SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Imposes new requirements on pharmacy benefit managers registered in this state.

Relating to pharmacy benefit managers; creating new provisions; and amending ORS 735.530 and
735.534.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> Section 2 of this 2019 Act is added to and made a part of ORS 735.530 to 6 735.552.

SECTION 2. (1) As used in this section, "out-of-pocket cost" means the amount paid by
an enrollee under the enrollee's coverage, including deductibles, copayments, coinsurance or
other expenses as prescribed by the Department of Consumer and Business Services by rule.
(2) A pharmacy benefit manager registered under ORS 735.532:

(2) A pharmacy benefit manager registered under Otto 755.552.

11 (a) May not require an enrollee to fill or refill prescriptions at a mail order pharmacy.

(b) May require an enrollee to fill or refill a prescription for a specialty drug at a spe cialty pharmacy.

(c) Shall allow an enrollee who is residing in a long term care facility to fill or refill a
prescription at a pharmacy that contracts with the long term care facility to dispense drugs
for the residents of the facility if:

17 (A) The contracted pharmacy is legally authorized to dispense; or

18 (B) The pharmacist at the pharmacy is properly trained to dispense.

(d)(A) Except for a specialty pharmacy as provided in paragraph (b) of this subsection,
shall allow a network pharmacy to mail, ship or deliver prescription drugs to its patients.

(B) May not require a patient signature as proof of delivery of a mailed or shipped pre scription drug if the network pharmacy maintains a mailing or shipping log signed by a rep resentative of the pharmacy or maintains each notification of delivery provided by the United
States Postal Service or a package delivery service.

(C) Is not required to reimburse a delivery fee charged by a pharmacy for a delivery de scribed in subparagraph (A) of this paragraph unless the fee is specified in the contract be tween the pharmacy benefit manager and the pharmacy.

28 (e) May not penalize a network pharmacy for or otherwise directly or indirectly prevent

a network pharmacy from informing an enrollee of the difference between the out-of-pocket 1 2 cost to the enrollee to purchase a prescription drug using the enrollee's pharmacy benefit and the pharmacy's retail price for the prescription drug. 3 (3) The Department of Consumer and Business Services shall adopt rules to carry out the 4 provisions of this section. 5 SECTION 3. ORS 735.530 is amended to read: 6 735.530. As used in ORS 735.530 to 735.552: 7 (1) "Claim" means a request from a pharmacy or pharmacist to be reimbursed for the cost of 8 9 filling or refilling a prescription for a drug or for providing a medical supply or service. 13	(15) "340B pharmacy" means a pharmacy that is authorized to purchase drugs at a dis-
14	count under 42 U.S.C. 256b.

17	(a)(A) "Generally available for purchase" means a drug is available for purchase by sim-

(i) May not retroactively deny or reduce a claim for reimbursement of the cost of ser-2627vices after the claim has been adjudicated by the pharmacy benefit manager unless the: (A) Adjudicated claim was submitted fraudulently; 28(B) Pharmacy benefit manager's payment on the adjudicated claim was incorrect because 2930 the pharmacy or pharmacist had already been paid for the services; 31 (C) Services were improperly rendered by the pharmacy or pharmacist; or (D) Pharmacy or pharmacist agrees to the denial or reduction prior to the pharmacy 32benefit manager notifying the pharmacy or pharmacist that the claim has been denied or 33 34 reduced. 35(3) Subsection (2)(i) of this section may not be construed to limit pharmacy claim audits under ORS 735.540 to 735.552. 36 37 [(3)] (4) A pharmacy benefit manager must establish a process by which a network pharmacy 38 may appeal [its reimbursement for a drug subject to maximum allowable cost pricing. A network pharmacy may appeal a maximum allowable cost if the reimbursement for the drug is less than the net 39 amount that the network pharmacy paid to the supplier of the drug. An appeal requested under this 40 section must be completed within 30 calendar days of the pharmacy making the claim for which appeal 41 has been requested] the reimbursement paid by the pharmacy benefit manager if the re-42 imbursement is less than the pharmacy's net cost of the drug as reflected on the invoice 43 from the supplier of the drug. The process must allow a pharmacy no less than 60 days after 44 the claim is reimbursed to file the appeal. 45

(5) A pharmacy benefit manager shall allow a network pharmacy to submit the doc-1 2 umentation in support of its appeal on paper or electronically and may not: (a) Refuse to accept an appeal submitted by a person acting on behalf of the network 3 4 pharmacy; (b) Refuse to accept an appeal for the reason that the appeal is submitted along with 5 other claims or appeals; or 6 (c) Impose requirements or establish procedures that have the effect of unduly ob-7 structing or delaying an appeal. 8 9 [(4)] (6) A pharmacy benefit manager must provide as part of the appeals process established under subsection [(3)] (4) of this section: 10 (a) A telephone number at which a network pharmacy may contact the pharmacy benefit man-11 12ager and speak with an individual who is responsible for processing appeals; 13 (b) A final response to an appeal of a maximum allowable cost within seven business days; and (c) If the appeal is denied[,]: 14 15 (A) The reason for the denial and the national drug code of a multiple source drug or generic drug that may be purchased by similarly situated pharmacies at a price that is *[equal to or less* 16 than] at or below the maximum allowable cost. 17 18 (B) If the reason for the denial is that the drug was generally available for purchase at a price that was at or below the maximum allowable cost, the location where the drug was 19 available at that price when the claim for reimbursement was submitted by the network 2021pharmacy. 22[(5)(a)] (7)(a) If an appeal is upheld under this section, the pharmacy benefit manager shall [make an adjustment for the pharmacy that requested the appeal from the date of initial adjudication 23forward]: 24 (A) Reimburse the network pharmacy's claim as submitted; 25(B) Allow the network pharmacy to submit an adjusted claim and reimburse the adjusted 2627claim without any additional charges; and (C) For all subsequent claims for reimbursement of the cost of the drug submitted by the 28network pharmacy and all similarly situated pharmacies under the same ownership as the 2930 network pharmacy, pay the pharmacy's net cost for the drug as reflected on the invoice from 31 the supplier of the drug. 32(b) If the request for an adjustment has come from a critical access pharmacy, as defined by the Oregon Health Authority by rule for purposes related to the Oregon Prescription Drug Program, the 33 34 adjustment approved under paragraph (a) of this subsection shall apply only to critical access 35pharmacies. Section 2 of this 2019 Act and the amendments to ORS 735.530 and 735.534 39 by sections 3 and 4 of this 2019 Act apply to pharmacy benefits and to contracts between 40 pharmacies or pharmacists and pharmacy benefit managers entered into, renewed or ex-41 tended on or after the effective date of this 2019 Act. 4243
