# B-Engrossed House Bill 2377

Ordered by the House June 26 Including House Amendments dated April 15 and June 26

Sponsored by Representative SMITH DB, Senator ROBLAN, Representative MCKEOWN; Representatives BONHAM, LEIF, Senator HEARD (Presession filed.)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Appropriates moneys from General Fund to Oregon Department of Administrative Services for purpose of implementing first phase of sediment study of lower Rogue River.]

[Appropriates moneys' from General Fund to department for payment to Umatilla County to reimburse water right holders for increased pumping costs of surface water that is used in lieu of ground water.]

Transfers moneys from certain funds and accounts to General Fund for general governmental purposes.

Provides for continued use of marijuana revenues for purposes related to mental health and alcohol and drug abuse.

Modifies statement of legislative intent relating to programs for rent assistance for low income households.

Permits continued use of moneys transferred to Trust for Cultural Development Account for marketing and promotional costs.

Repeals law relating to Legal Aid Account.

Increases salaries of certain judges. Creates new judgeships in certain counties.

Removes linkage between salaries of legislators and salaries of circuit court judges.

Modifies law relating to expense allowance for members of Legislative Assembly for periods when Legislative Assembly is not in session.

Increases governmental service expense transfer to Legislative Fiscal Office Operating Fund.

Establishes University Innovation Research Fund in State Treasury.

Provides that Department of Justice may increase rate of charges for legal assistance above legislatively budgeted rate only after notice to Joint Committee on Ways and Means or Emergency Board.

Requires Department of Justice to report to Joint Committee on Ways and Means on recoveries used for purposes other than certain legal costs or deposit into Department of Justice Protection and Education Revolving Account. Directs Department of Transportation to transfer moneys from Statewide Transportation

Directs Department of Transportation to transfer moneys from Statewide Transportation Improvement Fund to Elderly and Disabled Special Transportation Fund.

Declares emergency, effective [July 1, 2019] on passage.

(B) Twenty percent of the moneys in the account must be used solely for [*purposes for which moneys in the Mental Health Alcoholism and Drug Services Account established under ORS 430.380 may be used*] mental health treatment or for alcohol and drug abuse prevention, early intervention and treatment;

(C) Fifteen percent of the moneys in the account must be used solely for purposes for which
 moneys in the State Police Account established under ORS 181A.020 may be used; and

(D) Five percent of the moneys in the account must be used solely for purposes related to al-cohol and drug abuse prevention, early intervention and treatment services.

(4)(a) A city that has an ordinance prohibiting the establishment of a premises for which issuance of a license under ORS 475B.070, 475B.090, 475B.100 or 475B.105 is required is not eligible to
receive transfers of moneys under subsection (3)(b)(A) of this section.

(b) A county that has an ordinance prohibiting the establishment of a premises for which issuance of a license under ORS 475B.070 is required is not eligible to receive transfers of moneys under
subsection (3)(b)(B)(i) of this section.

(c) A county that has an ordinance prohibiting the establishment of a premises for which issuance of a license under ORS 475B.090, 475B.100 or 475B.105 is required is not eligible to receive
transfers of moneys under subsection (3)(b)(B)(ii) of this section.

(5) In a form and manner prescribed by the Oregon Liquor Control Commission, each city and county in this state shall certify with the commission whether the city or county has an ordinance prohibiting the establishment of a premises for which issuance of a license under ORS 475B.070, 475B.090, 475B.100 or 475B.105 is required. If a city fails to comply with this subsection, the city is not eligible to receive transfers of moneys under subsection (3)(b)(A) of this section. ## ECONOMIC DEVELOPMENT

SECTION 21. The University Innovation Research Fund is established in the State 14 15 Treasury, separate and distinct from the General Fund. Interest earned by the University Innovation Research Fund must be credited to the fund. The fund consists of all moneys 16 appropriated, allocated, deposited or transferred to the fund by the Legislative Assembly or 17 18 otherwise and any donations or grants received for the purpose of the fund. Moneys in the 19 fund are continuously appropriated to the Oregon Business Development Department to 20 make grants to public universities listed in ORS 352.002 or grants to the Oregon Health and 21Science University for the purpose of matching competitive federal research grant awards.

subject to allotment. Upon request of the Attorney General, the State Treasurer shall create subaccounts within the account for the purposes of managing moneys in the account and allocating those moneys to the activities described in subsection (1) of this section.

15 (3) Except as otherwise provided by law, all sums of money received by the Department of Justice under a judgment, settlement, compromise or assurance of voluntary compliance, including 16 damages, restitution, refunds, attorney fees, costs, disbursements and other recoveries, but excluding 17 18 civil penalties under ORS 646.642, in proceedings described in subsection (1)(c) of this section shall, 19 upon receipt, be deposited with the State Treasurer to the credit of the Department of Justice Pro-20 tection and Education Revolving Account. However, if the action or suit was based on an expenditure or loss from a public body or a dedicated fund, the amount of such expenditure or loss, after 2122deduction of attorney fees and expenses awarded to the department by the court or agreed to by the 23parties, if any, shall be credited to the public body or dedicated fund and the remainder thereof credited to the Department of Justice Protection and Education Revolving Account. 24

(4) If the Department of Justice recovers restitution or refunds in a proceeding described in subsection (1)(c) of this section, and the department cannot determine the persons to whom the restitution or refunds should be paid or the amount of the restitution or refund payable to individual claimants is de minimis, the restitution or refunds may not be deposited in the Department of Justice Protection and Education Revolving Account and shall be deposited in the General Fund.

(5) Before April 1 of each odd-numbered year, the Department of Justice shall report to the Joint
 Committee on Ways and Means:

(a) The department's projection of the balance in the Department of Justice Protection and Ed ucation Revolving Account at the end of the biennium in which the report is made and at the end
 of the following biennium;

(b) The amount of the balance held for restitution and refunds; and

(c) An estimate of the department's anticipated costs and expenses under subsection (1)(b) and
(c) of this section for the biennium in which the report is made and for the following biennium.

(d) Any judgment, settlement, compromise or other recovery, the proceeds of which are
 used for purposes other than:

40 (A) For deposit into the Department of Justice Protection and Education Revolving Ac-41 count; or

42 (B) For payment of legal costs related to the judgment, settlement, compromise or other
 43 recovery.

(6) The Joint Committee on Ways and Means, after consideration of recommendations made by
 the Department of Justice, shall use the information reported under subsection (5) of this section to

1	determine an appropriate balance for the revolving account.

3	TRANSPORTATION

5	SECTION 24. Notwithstanding ORS 184.751, the Department of Transportation shall
6	transfer the amount of \$10,100,000 from the Statewide Transportation Improvement Fund
7	established under ORS 184.751 to the Elderly and Disabled Special Transportation Fund es-
8	tablished under ORS 391.800, to be used for the purposes of distribution to transit entities
9	to support elderly and disabled transit services. The transfer shall be made on July 1, 2019.

13	SECTION 25. The unit captions used in this 2019 Act are provided only for the conven-
14	ience of the reader and do not become part of the statutory law of this state or express any
15	legislative intent in the enactment of this 2019 Act.

17	EMERGENCY CLAUSE

19	SECTION 26. This 2019 Act being necessary for the immediate preservation of the public
20	peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect
21	on its passage.
