

# House Bill 2447

Sponsored by Representative GREENLICK (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires Director of the Oregon Health Authority to provide forum for all vertically integrated, nonprofit health care systems in Oregon to collaborate to envision health care delivery system for Oregon's future. Requires supervision of collaboration by director or director's designee and exempts collaborative activities from federal antitrust law under state action doctrine.

## A BILL FOR AN ACT

2 Relating to the future of health care delivery in Oregon.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Legislative Assembly declares that it is in the best interest of the**  
5 **people of Oregon for the competing health care systems in this state to come together and**  
6 **find a way to envision the future of health care delivery in this state. The Legislative As-**  
7 **sembly therefore declares its intent to exempt from state antitrust laws, and to provide im-**  
8 **munity from federal antitrust laws through the state action doctrine, the collaborative**  
9 **activities described in subsection (2) of this section, that might otherwise be constrained by**  
10 **such laws.**

11 **(2) The Director of the Oregon Health Authority shall provide a forum for individuals**  
12 **representing all of the vertically integrated, nonprofit health care systems in this state to**  
13 **participate in meaningful and open discussions and engage in a good faith collaboration to**  
14 **create the experimental, prototype health care of tomorrow.**

15 **(3) The collaboration must be guided by the following principals:**

16 **(a) Health care must be readily accessible throughout every community in this state;**

17 **(b) High quality health care must be provided at a cost much lower than the cost of**  
18 **health care today;**

19 **(c) The experimental, prototype health care of tomorrow must incorporate innovations**  
20 **that are gathered from the best minds around the world and can be rapidly implemented**  
21 **throughout the delivery system;**

22 **(d) The experimental, prototype health care of tomorrow must continuously implement**  
23 **sufficient improvements in health care to completely offset any increases in cost over ex-**  
24 **tended periods of time; and**

25 **(e) The nonprofit health care systems participating in the experimental, prototype health**  
26 **care of tomorrow may not be competitors, but must work together in an integrated fashion**  
27 **to maximize their shared social missions.**

28 **(4) The director or the director's designee shall engage in state supervision of the col-**  
29 **laboration to ensure that the discussions and activities of the participants in the collab-**  
30 **oration are limited to the activities described in this section.**
