

# House Bill 2512

Sponsored by Representative DOHERTY; Representative HOLVEY (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires one member of State Board of Education to be engaged in teaching as licensed teacher.  
Declares emergency, effective on passage.

## A BILL FOR AN ACT

1  
2 Relating to membership of State Board of Education; amending ORS 326.021; and declaring an  
3 emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 326.021 is amended to read:

6 326.021. (1) The State Board of Education shall consist of:

7 (a) The State Treasurer, or the designee of the State Treasurer;

8 (b) The Secretary of State, or the designee of the Secretary of State; and

9 (c) [*Seven*] **Eight** members, appointed by the Governor for a term of four years beginning July  
10 1 of the year of appointment, subject to confirmation by the Senate in the manner provided in ORS  
11 171.562 and 171.565. A person appointed under this paragraph may not be appointed to serve con-  
12 secutively more than two full terms as a board member.

13 (2) In making appointments under subsection (1) of this section, the Governor shall select from  
14 residents of Oregon one member from each congressional district and [*two*] **three** members from the  
15 state at large. [*An*] **One** appointed member [*may not*] **must** be engaged in teaching [*or participate*  
16 *in the administration or operation of any school*] **as a licensed teacher in this state**.

17 (3) The Governor may remove appointed members of the State Board of Education for cause at  
18 any time after notice and public hearing.

19 (4) The State Treasurer and the Secretary of State, or the designee of the State Treasurer or  
20 Secretary of State, are nonvoting, ex officio members of the board.

21 (5) The board shall coordinate and collaborate with the Chief Education Office as provided by  
22 section 1, chapter 519, Oregon Laws 2011.

23 **SECTION 2.** ORS 326.021, as amended by section 42, chapter 774, Oregon Laws 2015, is  
24 amended to read:

25 326.021. (1) The State Board of Education shall consist of:

26 (a) The State Treasurer, or the designee of the State Treasurer;

27 (b) The Secretary of State, or the designee of the Secretary of State; and

28 (c) [*Seven*] **Eight** members, appointed by the Governor for a term of four years beginning July  
29 1 of the year of appointment, subject to confirmation by the Senate in the manner provided in ORS  
30 171.562 and 171.565. A person appointed under this paragraph may not be appointed to serve con-  
31 secutively more than two full terms as a board member.
