# A-Engrossed House Bill 2576

Ordered by the House March 11 Including House Amendments dated March 11

Sponsored by Representatives MCKEOWN, MCLAIN; Representatives GOMBERG, HOLVEY (Presession filed.)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Provides that when person's vehicle is totaled or substantially altered person may keep registration plates with vehicle if vehicle issued branded title or person may transfer plates to another vehicle if vehicle's title is canceled or retired.]

Provides that under certain circumstances person with totaled or substantially altered vehicle may apply to Department of Transportation to keep same registration plates and remaining registration period.

Allows person to apply with department to transfer plates from vehicle for which department previously received totaled or substantially altered notification. Allows person to transfer special interest registration plates under certain circum-

Allows person to transfer special interest registration plates under certain circumstances.

4	Be It Enacted by the People of the State of Oregon:
5	SECTION 1. ORS 98.858 is amended to read:
6	98.858. (1) A tower in physical possession of a motor vehicle shall permit the owner or person
7	in lawful possession of a motor vehicle the tower has towed to:
8	(a) Redeem or inspect the motor vehicle:
9	(A) Between 8 a.m. and 6 p.m. on business days;
10	(B) At all other hours, within 60 minutes after asking the tower to release or allow for the in-
11	spection of the motor vehicle; and
12	(C) Within 30 minutes of a time mutually agreed upon between the tower and the owner or
13	person in lawful possession of the motor vehicle;
14	(b) Contact the tower at any time to receive information about the location of the motor vehicle
15	and instructions for obtaining release of the motor vehicle; and
16	(c) Obtain all personal property of an emergency nature in the motor vehicle and the motor
17	vehicle's registration plates within the time allowed under paragraph (a) of this subsection.
18	(2) A tower may not charge the owner or person in lawful possession of the motor vehicle a fee
19	in any amount to obtain personal property of an emergency nature or registration plates except
20	for a gate fee between the hours of 6 p.m. and 8 a.m. on business days, or on a Saturday, a Sunday
21	or a legal holiday.
22	(3) As used in this section, "personal property of an emergency nature" includes but is not
23	limited to prescription medication, eyeglasses, hearing aids, clothing, identification, a wallet, a

The Department of Transportation shall comply with the following procedures upon re-3 ceiving a certificate of title or other notice in accordance with the provisions of ORS 819.010, 4 819.012 or 819.014: 5 (1) If the department is satisfied that the vehicle is [totaled,] wrecked, dismantled[,] or disas-6 sembled [or substantially altered], the department shall cancel and retire the registration and title 7 of the vehicle. (b) A vehicle approved by the department as a vehicle of special interest at the time of 1 application. 2 (9) If a person described in subsection (8) of this section provides the department with 3 only one special interest registration plate for transfer and the department's vehicle records 4 show the special interest registration plate belongs to a vehicle record with no owner 5 matching an applicant, the applicant shall provide proof, as determined by the department 6 by rule, that the plate is no longer used on the vehicle it is currently showing being regis-7 tered to in the department's vehicle records. 8 9 SECTION 4. ORS 803.575 is amended to read: 803.575. (1) The fee for issuance of a duplicate or replacement registration card under ORS 10 803.510 is \$5. 11 12 (2) The fee for issuance of a replacement or duplicate registration plate under ORS 803.530 is the fee established under ORS 803.570, together with a fee of \$5 if the plate is issued at the time 13 of renewal of registration or a fee of \$10 if the plate is issued at any other time. 14 15 (3) The fee for transfer of registration plate under ORS 803.530 [or 803.590] is \$6. 16 (4) The fee for issuance of replacement registration stickers under ORS 803.555, is \$10. (5) The fee for issuance of both replacement or duplicate registration plates and replacement 17 registration stickers, when issued at the same time, is the fee established under ORS 803.570, to-18 gether with a fee of \$5 if the plate and stickers are issued at the time of renewal of registration or 19 a fee of \$10 if the plate and stickers are issued at any other time. 20(6) A fee paid under subsection (2), (4) or (5) of this section includes the cost of any duplicate 2122or replacement registration card issued.

24 803.060. A title does not require a renewal and is valid until one of the following occurs:

25 (1) The vehicle is destroyed[,] or dismantled [or substantially altered].

26 (2) Any interest reflected on the title changes.
