# House Bill 2648

Sponsored by Representative GORSEK (Presession filed.)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Permits board of community college to determine whether to establish campus police department and commission police officers.

8 Be It Enacted by the People of the State of Oregon:

9 <u>SECTION 1.</u> Sections 2 and 3 of this 2019 Act are added to and made a part of ORS 10 chapter 341.

<u>SECTION 2.</u> (1) A board of education of a community college district may, in the board's
 sole discretion, do all of the following:

(a) Establish a police department and commission one or more employees as police officers in the manner and with all of the privileges and immunities set forth in section 3 of this 2019 Act. When a board establishes a police department and commissions one or more employees as police officers, the president of the community college, in cooperation with the chief of the police department, shall establish a process by which the community college will receive and respond to complaints involving the policies of the police department and the conduct of the police officers.

(b) Commission special campus security officers who, when acting in the scope of their employment, shall have stop and frisk authority as set forth in ORS 131.605 to 131.625 and probable cause arrest authority and the accompanying immunities as set forth in ORS 133.310 and 133.315. Special campus security officers may not be authorized to carry firearms as police officers and, except as provided in subsection (2) of this section, may not be considered police officers for purposes of ORS 181A.355, 238.005, 243.005 or 243.736.

(2) A community college, acting by and through the community college's special campus
 security officers, is a criminal justice agency for purposes of rules adopted pursuant to ORS
 181A.280 (3).

29 <u>SECTION 3.</u> (1) The board of education of a community college district may authorize the 30 community college to establish a police department and commission one or more employees 31 as police officers. A police department established under this section has all of the authority

and immunity of a municipal police department of this state. 1 2 (2) Police officers commissioned under this section: (a) May enforce criminal laws and any administrative rules and policies adopted by the 3 board; and 4  $\mathbf{5}$ (b) Have all the authority and immunity of a peace officer or police officer of this state. (3) When a community college establishes a police department and commissions one or 6 more employees as police officers, the president of the community college, in cooperation 7 with the chief of the police department, shall establish a process by which the community 8 9 college will receive and respond to complaints involving the policies of the police department and the conduct of the police officers. 10 (4) The board may: 11 12(a) Enter into an agreement, or authorize the community college under the board's control to enter into an agreement, with a municipal corporation or any department, agency or 13 political subdivision of this state for the provision of mutual aid by their respective police 14 15 officers. 16 (b) Adopt standards to carry out the provisions of this section. (d) "Personal representative" means a person selected under subsection (2) of this section to 32accompany the victim of a crime to certain phases of an investigation and prosecution. 33 34 (e) "Protective service worker" means an employee or contractor of a local or state agency whose role it is to protect children or vulnerable adults from abuse or neglect. 35(2) A victim of a person crime, who is at least 15 years of age at the time the crime is com-36 37 mitted, may select a person who is at least 18 years of age as the victim's personal representative 38 for purposes of this section. The victim may not select a person who is a suspect in, or a party or witness to, the crime as a personal representative. 39 (3) Except for grand jury proceedings and child abuse assessments occurring at a child advocacy 40 center recognized by the Department of Justice, a personal representative may accompany the vic-41 tim to those phases of the investigation, including medical examinations, and prosecution of the 42 crime at which the victim is entitled or required to be present. 43 (4) A health care provider, law enforcement agency, protective service worker or court may not 44 prohibit a personal representative from accompanying a victim as authorized by subsection (3) of 45

1 this section unless the health care provider, law enforcement agency, protective service worker or 2 court believes that the personal representative would compromise the process.

3 (5) A health care provider, law enforcement agency, protective service worker or court is im-4 mune from any liability, civil or criminal, that might otherwise be incurred or imposed with respect 5 to a decision under subsection (4) of this section to prohibit a personal representative from accom-6 panying a victim.

7 (6) The fact that a personal representative was allowed or was not allowed to accompany a 8 victim may not be used as a basis for excluding otherwise admissible evidence.

9 (7) The fact that a victim has or has not selected a personal representative under this section 10 may not be used as evidence in the criminal case.

11 <u>SECTION 5.</u> ORS 238.005, as amended by section 4, chapter 54, Oregon Laws 2018, is amended 12 to read:

13 238.005. For purposes of this chapter:

(1) "Active member" means a member who is presently employed by a participating public em ployer in a qualifying position and who has completed the six-month period of service required by
 ORS 238.015.

(2) "Annuity" means payments for life derived from contributions made by a member as providedin this chapter.

(3) "Board" means the Public Employees Retirement Board.

(4) "Calendar year" means 12 calendar months commencing on January 1 and ending on De cember 31 following.

(5) "Continuous service" means service not interrupted for more than five years, except that such continuous service shall be computed without regard to interruptions in the case of:

(a) An employee who had returned to the service of the employer as of January 1, 1945, and
who remained in that employment until having established membership in the Public Employees
Retirement System.

(b) An employee who was in the armed services on January 1, 1945, and returned to the service of the employer within one year of the date of being otherwise than dishonorably discharged and remained in that employment until having established membership in the Public Employees Retirement System.

(6) "Creditable service" means any period of time during which an active member is being paid a salary by a participating public employer and for which benefits under this chapter are funded by employer contributions and earnings on the fund. For purposes of computing years of "creditable service," full months and major fractions of a month shall be considered to be one-twelfth of a year and shall be added to all full years. "Creditable service" includes all retirement credit received by a member.

(7) "Earliest service retirement age" means the age attained by a member when the member
 could first make application for retirement under the provisions of ORS 238.280.

(8) "Employee" includes, in addition to employees, public officers, but does not include:

40 (a) Persons engaged as independent contractors.

(b) Seasonal, emergency or casual workers whose periods of employment with any public em ployer or public employers do not total 600 hours in any calendar year.

43 (c) Persons provided sheltered employment or made-work by a public employer in an employment
 44 or industries program maintained for the benefit of such persons.

45 (d) Persons employed and paid from federal funds received under a federal program intended

1 primarily to alleviate unemployment. However, any such person shall be considered an "employee"

2 if not otherwise excluded by paragraphs (a) to (c) of this subsection and the public employer elects 3 to have the person so considered by an irrevocable written notice to the board.

(9) "Final average salary" means whichever of the following is greater:

(a) The average salary per calendar year paid by one or more participating public employers to 10 an employee who is an active member of the system in three of the calendar years of membership 11 12 before the effective date of retirement of the employee, in which three years the employee was paid the highest salary. The three calendar years in which the employee was paid the largest total salary 13 may include calendar years in which the employee was employed for less than a full calendar year. 14 15 If the number of calendar years of active membership before the effective date of retirement of the 16 employee is three or fewer, the final average salary for the employee is the average salary per cal-17 endar year paid by one or more participating public employers to the employee in all of those years, 18 without regard to whether the employee was employed for the full calendar year.

(b) One-third of the total salary paid by a participating public employer to an employee who is
an active member of the system in the last 36 calendar months of active membership before the effective date of retirement of the employee.

(10) "Firefighter" does not include a volunteer firefighter, but does include:

23 (a) The State Fire Marshal, the chief deputy fire marshal and deputy state fire marshals; and

(b) An employee of the State Forestry Department who is certified by the State Forester as a
professional wildland firefighter and whose primary duties include the abatement of uncontrolled
fires as described in ORS 477.064.

(11) "Fiscal year" means 12 calendar months commencing on July 1 and ending on June 30 fol-lowing.

29 (12) "Fund" means the Public Employees Retirement Fund.

(13) "Inactive member" means a member who is not employed in a qualifying position, whose
 membership has not been terminated in the manner described by ORS 238.095 and who is not retired
 for service or disability.

(14) "Institution of higher education" means a public university listed in ORS 352.002, the
 Oregon Health and Science University and a community college, as defined in ORS 341.005.

(15) "Member" means a person who has established membership in the system and whose mem bership has not been terminated as described in ORS 238.095. "Member" includes active, inactive
 and retired members.

(a) For a person who establishes membership in the system before January 1, 1996, as described
in ORS 238.430, 55 years of age if the employee retires at that age as a police officer or firefighter
or 58 years of age if the employee retires at that age as other than a police officer or firefighter.

(b) For a person who establishes membership in the system on or after January 1, 1996, as described in ORS 238.430, 55 years of age if the employee retires at that age as a police officer or
firefighter or 60 years of age if the employee retires at that age as other than a police officer or

2 (18) "Pension" means annual payments for life derived from contributions by one or more public employers. 3

(19) "Police officer" includes: 4

(a) Employees of institutions defined in ORS 421.005 as Department of Corrections institutions 5 whose duties, as assigned by the Director of the Department of Corrections, include the custody of 6 persons committed to the custody of or transferred to the Department of Corrections and employees 7 of the Department of Corrections who were classified as police officers on or before July 27, 1989, 8 9 whether or not such classification was authorized by law.

(b) Employees of the Department of State Police who are classified as police officers by the 10 Superintendent of State Police. 11

12 (c) Employees of the Oregon Liquor Control Commission who are classified as regulatory spe-13 cialists by the administrator of the commission.

(d) Sheriffs and those deputy sheriffs or other employees of a sheriff whose duties, as classified 14 15 by the sheriff, are the regular duties of police officers or corrections officers.

16 (e) Police chiefs and police personnel of a city who are classified as police officers by the council or other governing body of the city. 17

18 (f) Police officers who are commissioned by a community college or university under ORS 352.121 or 353.125 or section 3 of this 2019 Act and who are classified as police officers by the 19 20 university.

(g) Parole and probation officers employed by the Department of Corrections, parole and pro-2122bation officers who are transferred to county employment under ORS 423.549 and adult parole and 23probation officers, as defined in ORS 181A.355, who are classified as police officers for the purposes of this chapter by the county governing body. If a county classifies adult parole and probation offi-24 cers as police officers for the purposes of this chapter, and the employees so classified are repres-25ented by a labor organization, any proposal by the county to change that classification or to cease 2627to classify adult parole and probation officers as police officers for the purposes of this chapter is a mandatory subject of bargaining. 28

(h) Police officers appointed under ORS 276.021 or 276.023. 29

(i) Employees of the Port of Portland who are classified as airport police by the Board of Com-30 31 missioners of the Port of Portland.

(j) Employees of the State Department of Agriculture who are classified as livestock police of-32ficers by the Director of Agriculture. 33

34 (k) Employees of the Department of Public Safety Standards and Training who are classified by 35the department as other than secretarial or clerical personnel.

(L) Investigators of the Criminal Justice Division of the Department of Justice. 36

37 (m) Corrections officers as defined in ORS 181A.355.

(n) Employees of the Oregon State Lottery Commission who are classified by the Director of the 38 Oregon State Lottery as enforcement agents pursuant to ORS 461.110. 39

(o) The Director of the Department of Corrections. 40

(p) An employee who for seven consecutive years has been classified as a police officer as de-41 fined by this section, and who is employed or transferred by the Department of Corrections to fill 42 a position designated by the Director of the Department of Corrections as being eligible for police 43 officer status. 44

(q) An employee of the Department of Corrections classified as a police officer on or prior to

1 July 27, 1989, whether or not that classification was authorized by law, as long as the employee 2 remains in the position held on July 27, 1989. The initial classification of an employee under a sys-3 tem implemented pursuant to ORS 240.190 does not affect police officer status.

4 (r) Employees of a school district who are appointed and duly sworn members of a law 5 enforcement agency of the district as provided in ORS 332.531 or otherwise employed full-time as 6 police officers commissioned by the district.

(s) Employees at youth correction facilities and juvenile detention facilities under ORS 419A.050,
419A.052 and 420.005 to 420.915 who are required to hold valid Oregon teaching licenses and who
have supervisory, control or teaching responsibilities over juveniles committed to the custody of the
Department of Corrections or the Oregon Youth Authority.

(t) Employees at youth correction facilities as defined in ORS 420.005 whose primary job de scription involves the custody, control, treatment, investigation or supervision of juveniles placed
 in such facilities.

(u) Employees of the Oregon Youth Authority who are classified as juvenile parole and pro-bation officers.

(v) Employees of the Department of Human Services who are prohibited from striking under ORS
243.726 and whose duties include the care of residents of residential facilities, as defined in ORS
443.400, that house individuals with intellectual or developmental disabilities.

(20) "Prior service credit" means credit provided under ORS 238.442 or under ORS 238.225 (2)
to (6) (1999 Edition).

(21) "Public employer" means the state, one of its agencies, any city, county, or municipal or public corporation, any political subdivision of the state or any instrumentality thereof, or an agency created by one or more such governmental organizations to provide governmental services. For purposes of this chapter, such agency created by one or more governmental organizations is a governmental instrumentality and a legal entity with power to enter into contracts, hold property and sue and be sued.

(22) "Qualifying position" means one or more jobs with one or more participating public employers in which an employee performs 600 or more hours of service in a calendar year, excluding any service in a job for which a participating public employer does not provide benefits under this
chapter pursuant to an application made under ORS 238.035.

(23) "Regular account" means the account established for each active and inactive member un der ORS 238.250.

(24) "Retired member" means a member who is retired for service or disability.

34 (25) "Retirement credit" means a period of time that is treated as creditable service for the 35 purposes of this chapter.

(26)(a) "Salary" means the remuneration paid an employee in cash out of the funds of a public
employer in return for services to the employer, plus the monetary value, as determined by the
