SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires health benefit plan to reimburse cost of covered telemedicine health service provided by health professional licensed or certified in this state if same health service is provided in person.

ORS 743A.058 is amended to read: 17743A.058. (1) As used in this section: 18 19 (a) "Health benefit plan" has the meaning given that term in ORS 743B.005. 20 (b) "Health professional" means a person, regardless of physical location, that is: (A) Licensed, certified or registered in this state to provide health [care] services [or supplies]; 2122and 23(B) Subject to the authority of one or more health licensing boards or licensing agencies in this state. 2425(c) "Health service" means diagnosis, treatment or supplies, or services ancillary to the diagnosis, treatment or supplies, provided by a physical or behavioral health professional to: 26 (A) A patient; 27 (B) A parent, guardian or authorized representative of a patient; or 28 (C) Another health professional on a patient's behalf. 29 30 [(c)] (d) "Originating site" means the physical location of [the] a patient. 31 (e) "Telemedicine" means the provision of a health service by any electronic means, in-

9	telemedicine health service that is provided [using synchronous two-way interactive video confer-
10	encing] to an enrollee in the plan regardless of where the enrollee is located if:
11	(a) The plan provides coverage of the health service when provided in person by a health pro-
12	fessional in the plan's network of providers;
13	(b) The health service is medically necessary;
14	(c) The health service is determined to be safely and effectively provided using [synchronous
15	two-way interactive video conferencing] telemedicine according to generally accepted health care
16	practices and standards; and
17	(d) The application and technology used to provide the health service meet all standards re-
18	quired by state and federal laws governing the privacy and security of protected health information.
19	(3) Health services covered in accordance with subsection (2) of this section may be re-
20	imbursed in an amount equal to:
21	(a) For a physical health service, 80 percent or more of the reimbursement paid by the
22	health benefit plan for the health service if provided in person; and
23	(b) For a behavioral health service, 90 percent or more of the reimbursement paid by the
24	health benefit plan for the health service if provided in person.
25	[(3)] (4) A health benefit plan may not:
26	(a) Distinguish between rural and urban originating sites in providing coverage under [sub-
27	section (2)] subsections (2) and (3) of this section.
28	(b) Require a health professional to have treated the patient previously as a condition
29	of covering telemedicine health service.
30	(c) Deny or restrict coverage for new patients or for patients being seen for follow up.
31	[(4)] (5) The coverage under subsection (2) of this section is subject to [:]
32	[(a)] the terms and conditions of the health benefit plan[; and]
33	[(b) The reimbursement specified in the contract between the plan and the health professional].
34	[(5)] (6) This section does not require a health benefit plan to reimburse a health

37	[(b) Who has not contracted with the plan].

44	[(c) "Telemedical" means delivered through a two-way electronic communication, including but not
45	limited to video, audio, Voice over Internet Protocol or transmission of telemetry, that allows a health

1 professional to interact with a patient, a parent or guardian of a patient or another health professional 2 on a patient's behalf, who is at an originating site.]

3 (c) "Telemedicine" has the meaning given that term in ORS 743A.058.

4 (2) A health benefit plan must provide coverage of a [*telemedical*] **telemedicine** health service 5 provided in connection with the treatment of diabetes if:

6 (a) The plan provides coverage of the health service when provided in person by the health 7 professional;

- 8 (b) The health service is medically necessary;
- 9 (c) The [telemedical] telemedicine health service relates to a specific patient; and

(d) One of the participants in the [telemedical] telemedicine health service is a representative
of an academic health center.

(3) A health benefit plan may not distinguish between rural and urban originating sites in pro viding coverage under subsection (2) of this section.

(4) A health benefit plan may subject coverage of a [*telemedical*] **telemedicine** health service under subsection (2) of this section to all terms and conditions of the plan, including but not limited to deductible, copayment or coinsurance requirements that are applicable to coverage of a comparable health service when provided in person.

(5) This section does not require a health benefit plan to reimburse a provider for a healthservice that is not a covered benefit under the plan.

20 (6) This section is exempt from ORS 743A.001.

21 <u>SECTION 3.</u> The amendments to ORS 743A.058 and 743A.185 by sections 1 and 2 of this 22 2019 Act apply to health benefit plans issued, renewed or extended on or after the effective 23 date of this 2019 Act.
