4	Be It Enacted by the People of the State of Oregon:
5	SECTION 1. ORS 418.653 is amended to read:
6	418.653. (1) Subject to the availability of funds [therefor], there is created an Oregon Youth
7	[Conservation] Corps that shall provide emergency services, public conservation, rehabilitation and
8	improvement programs. The corps shall be headed by a program director, and shall be administered
9	through the [Office of Community Colleges and Workforce Development] Higher Education Coordi-
10	nating Commission.
11	(2) Upon implementation of subsection (1) of this section, there shall be created an Oregon
12	Youth [Conservation] Corps Advisory [Committee] Board to consist of nine members, three to be
13	appointed by the President of the Senate, three to be appointed by the Speaker of the House of
14	Representatives and three public members to be appointed by the Governor. No more than one
15	Senator and one Representative shall be appointed.
16	(3) [Committee] Board members may receive reimbursement of necessary and actual expenses
17	under ORS 292.495 (2), but may not receive compensation under ORS 292.495 (1) or otherwise for
18	participation as a [committee] board member.
19	(4) [Committee] Board members may be removed by the appointing authority. Vacancies shall

418.658. (1) The program director of the Oregon Youth [*Conservation*] Corps shall establish a separate program known as the Oregon Community Stewardship Corps. In addition to the established purposes of the Oregon Youth [*Conservation*] Corps, the purpose of the Oregon Community Stewardship Corps is to promote community service activities throughout the state for a broad cross section of Oregon disadvantaged and at-risk youth through programs that also include appropriate educational and job training opportunities for participants.

(2) In addition to projects submitted under ORS 418.660 (1), projects of the Oregon Community
 Stewardship Corps may include, but shall not be limited to:

- 38 (b) Elderly and disabled care services.
- 39 (c) Literacy education programs.

(3) The Oregon Community Stewardship Corps shall offer employment and educational opportu nities of at least three but not more than 12 months' duration for selected participants.

in [tuition] support vouchers that can be used [at any career school or post-secondary educational

4 (5) All Oregonians who are at least 13 years of age and under 25 years of age are eligible to 5 participate in the program. To ensure that Oregon Community Stewardship Corps participants rep-6 resent a broad cross section of Oregonians, special emphasis shall be given to recruiting school 7 dropouts and other disadvantaged and at-risk youth, according to criteria established by the Oregon 8 Youth [Conservation] Corps Advisory [Committee] Board.

9 (6) To the extent practicable, the program director shall enlist state and federal agencies, local 10 government, nonprofit organizations and private businesses, and any combination of such entities, 11 to act as sponsors for programs administered under this section. Selection of sponsors shall be based 12 on criteria that include the following:

(a) The availability of other resources on a matching basis, including contributions from private

"Provider of care or services for children" includes a proctor foster home 8 certified by a child-caring agency under ORS 418.248.

 such as reduction in the hours of nonovertime work or wages or employment benefits;

(c) Not impair existing contracts for services or result in the substitution of state for otherfunds in connection with work that would otherwise be performed;

18 (d) Not substitute jobs assisted under ORS 418.650 to 418.663 for existing federally assisted jobs;

(e) Not employ any person when any other person is on layoff by an employer from the sameor any substantially equivalent job in the same area; and

(f) Not be used to employ any person to fill a job opening created by the act of an employer in laying off or terminating employment of any regular employee, otherwise reducing the regular workforce not supported under ORS 418.650 to 418.663, in anticipation of filling the vacancy so created by hiring a person to be supported under ORS 418.650 to 418.663.

(2) Where a labor organization represents employees who are engaged in similar work or a workers' cooperative is engaged in work in the same area to that proposed to be performed under the program for which an application is being developed, the organization or cooperative shall be notified and shall be afforded a reasonable period of time prior to the submission of the application in which to make comments to the applicant and to the program director of the Oregon Youth [Conservation] Corps.
